Beginning at a 5/8 inch rebar capped: MDL 4232 S located on the East boundary of Section 4 Twp. 30 N., R. 31 W., P.M.M., said point marking the Southeast corner of Plat No. 529, Lincoln County, Montana Records, said point bearing S01°14'22"W 594.34 feet from a 3 1/2 inch dia. Brass Capped Monument marking the Northeast corner of said Section 4; thence, along the South line of said Plat No. 529, N64°06'38"W 127.53 feet to a 5/8 inch rebar capped: MDL 4232 S marking the Southwesterly corner of said Plat No. 529; thence, S07°18'48"W 28.22 feet to a 5/8 inch rebar capped: MDL 4232 S; thence, S72°18'00"E 123.98 feet to a 5/8 inch rebar capped: MDL 4232 S located on the aforementioned East boundary of said Section 4; thence, along said East boundary, N01°14'22"E 10.00 feet to the point of beginning.

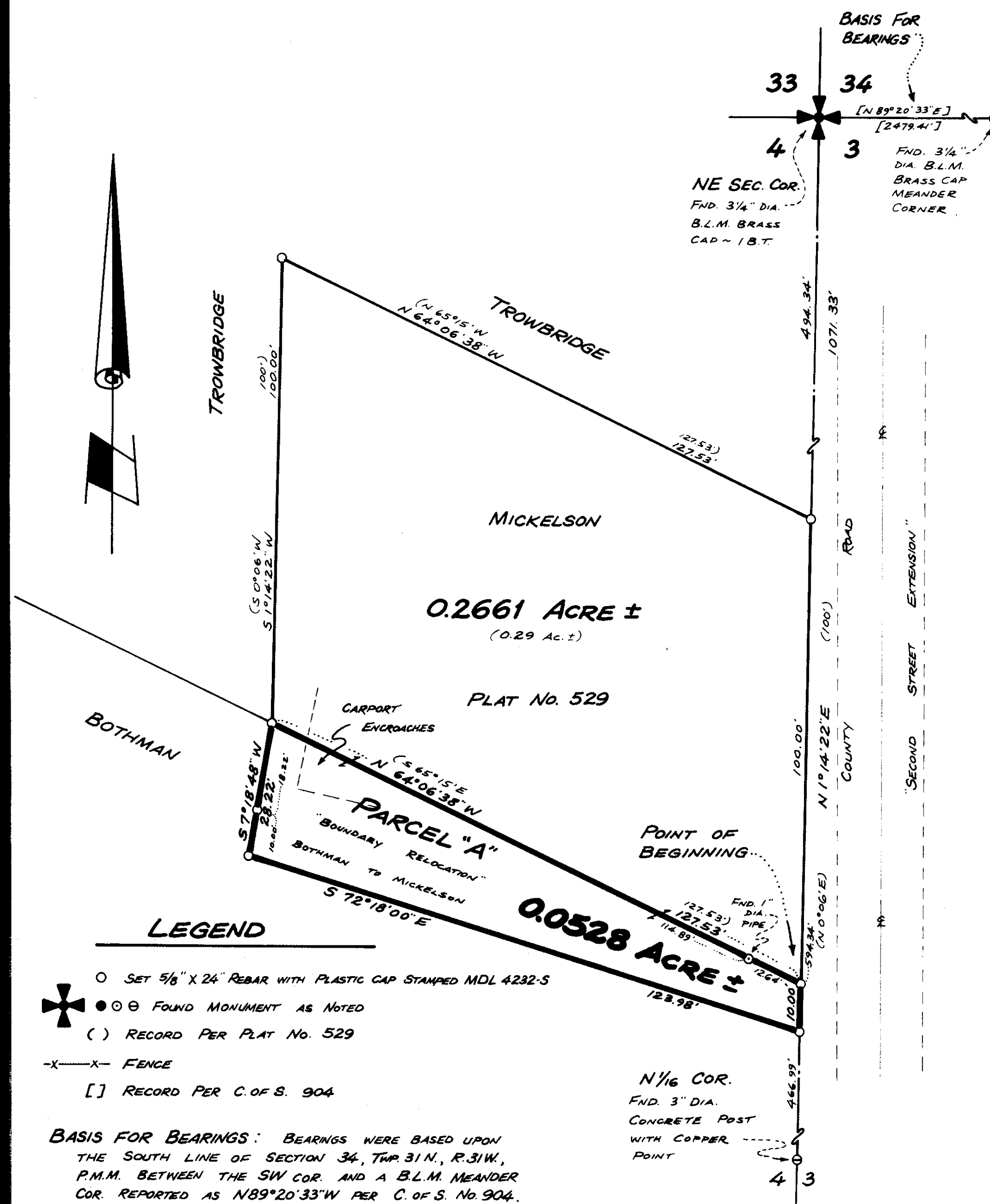
