1/4 SECTION CORNERS OF THIS SECTION WERE ESTABLISHED BY D. MUMBRUE IN 1893. REMONUMENTATION BY B.L.M. IN 1962 AND 1963. NO OTHER SURVEYS OF RECORD IN SECTION.

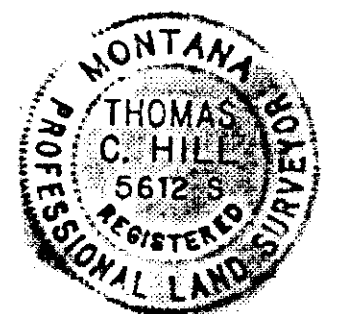
