

DESCRIPTION PARCEL "A"-"OCCASIONAL SALE"

A parcel of land near Troy in Lincoln County, Montana, being a part of Tract 1 per Certificate of Survey No. 500, lying within the S&4 of Section 18, Twp. 31 N., R. 33 W., P.M.M., containing 10.0000 acres, more or less, and more particularly described as follows:

Beginning at a p.L.M. prass Capped Monument marking the southeast corner of Section 18, Twp. 31N., R. 33 W., P.M.E.; thence, along the south line of said Section 18, N 890 lo' 12"W. 744.46 feet to a B.L.M. prass Capped Monument Meander Corner; thence, continuing along the south line of said Section 18, N 890 40' 42" W. 184.00 feet to the reported southwest corner of Tract 1 per Certificate of Survey No. 500 on the meander line of the right bank of the kootenai River; thence, following, generally, said meander line of the kootenai River, downstream, the following two courses: N 140 27' 27"W. 353.11 feet; thence, N 50° 32' 32"E 162.91 feet; thence, leaving said meander line, East 80.30 feet to a 5/8 inch rebar capped: MDL 4232-S, set as a witness corner; thence, continuing East 810.28 feet for a total distance of 890.58 feet to a 5/8 inch rebar capped: MDL 4232-S, on the east line of said Tract 1, reported to be on the east line of said Section 18; thence, along said east lines, S 00° 01' 23"E 455.98 feet to the Point of Beginning.

Together with that land lying between the meander line as shown hereon and the low water mark of the

kootenai River.

Including a 30.00 fcot wide Access and Utilities Easement parallel and immediately adjacent to the east line of Parcels "C" and "D" as shown hereon per C. of S. No. 905; also including a 30.00 foot wide Easement along the Existing Public Road crossing through the northeast corner of Parcel "D" per said C. of S. No. 905, all as shown hereon.

DESCRIPTION PARCEL "C"-"REMAINDER"

A parcel of land near Troy in Lincoln County, Montana, being a part of Tract 1 per Certificate of Survey No. 500, lying within the SEt of Section 18 Twp. 31N., R. 33 W., P.M.M., containing 5.0000 acres, more or less, and more particularly described as follows:

Beginning at a 5/8 inch rebar capped: MDL 4232-S, on the east line of Tract 1 per Certificate of Survey No. 500, reported to be on the east line of Section 18 Twp. 31N., R.33w., P.M.M. at a distance of 455.38 feet NOOOO1'23"W. from a b.L.M. Brass Capped Monument marking the southeast corner of said Section 18; thence, from said point of beginning, along said east lines, NOOOO1'23"W. 249.61 feet to a 5/8 inch rebar capped: MDL 4232-S; thence, leaving said section line West 800.11 feet to a 5/8 inch rebar, set as a witness corner; thence, continuing West 124.11 feet for a total distance of 924.22 feet to the northwest corner on the meander line of the right bank of the kootenai giver; thence, following, generally, said meander line of the kootenai River, upstream, the following two courses: S 250 57' 25"E. 220.24 feet; thence, S 500 32' 32"W. 81.16 feet; thence, leaving said meander line, East 80.30 feet to a 5/8 inch rebar capped: MDL 4232-S, set as a witness corner; thence, continuing East 810.28 feet for a total distance of 890.58 feet to the Point of Beginning.

Together with that land lying between the meander line as shown hereon and the low water mark of the kootenai River.

Including a 30.00 foot wide Access and Utilities Easement parallel and immediately adjacent to the east line of Parcel "D" per C. of S. No. 905; also including a 30.00 foot wide Easement along the Existing Public Road crossing through the northeast corner of Parcel "D" per said C. of S. No. 905, all as shown hereon.

Subject to a 30.00 foot wide Access and Utilities Easement parallel and immediately adjacent to the east line of the aforedescribed Farcel "C", containing 0.1719 acre, more or less, leaving a Net Area of 4.8281 acres, more or less, all as shown hereon.
