DESCRIPTION PARCEL "A" - "PARCEL OVER TWENTY ACRES"

A tract of land near Troy in Lincoln County, Montana, lying within the NE 1/4 of the NE 1/4 of Section 35 Twp. 32N., R. 34W., P.M.M., more particularly described as follows:

Beginning at the Southeast corner of the NE 1/4 of the NE 1/4 of said Section 35, from which a 3/4 inch dia. Aluminum Cap by 5612S bears S73°20'53"W 0.88 feet; thence, along the East line of said Section 35, N0°01'56"W 269.91 feet to a 5/8 inch dia. rebar capped: MDL 4232S on the Southwesterly right of way line of the Kilbrennan Lake Road (a 60.00 foot wide County Road Right of Way per Plat No.s 2147 and 2173) at a distance of 30.00 feet measured at right angles from the centerline thereof; thence, leaving the East line of said Section 35, along said Southwesterly right of way line the following eight courses: N38°41'30"W 6.37 feet to a 5/8 inch dia. rebar capped: JHN 4661S; thence, N38°41'30"W 75.81 feet to a 5/8 inch dia. rebar capped: JHN 4661S; thence, on the arc of a non-tangent curve to the left having a radius of 970.00 feet, which radius bears S48°52'22"W, turning through a central angle of 4°55'43" an arc length of 83.44 feet to a 5/8 inch dia. rebar capped: JHN 4661S where the radius bears S43°56'39"W; thence, N45°17'25"W 169.47 feet to a 5/8 inch dia. rebar capped: JHN 4661S; thence, on the arc of a non-tangent curve to the left having a radius of 870.00 feet, which radius bears S44°14'53"W, turning through a central angle of 6°33'13" an arc length of 99.51 feet to a 5/8 inch dia. rebar capped: JHN 4661S where the radius bears S37°41'40"W; thence, N52°07'09"W 202.12 feet to a 5/8 inch dia. rebar capped: JHN 4661S; thence, on the arc of a non-tangent curve to the right having a radius of 657.87 feet, which radius bears N37°54'00"E, turning through a central angle of 19°29'39" an arc length of 223.83 feet to a 5/8 inch dia. rebar capped: JHN 4661S where the radius bears N57°23'39"E; thence, N32°36'54"W 130.00 feet to a 5/8 inch dia. rebar capped: MDL 4232S; thence, leaving said Southwesterly right of way line, S51°35'36"W 806.89 feet to a 5/8 inch dia. rebar capped: MDL 4232S on the West line of the NE 1/4 of the NE 1/4 of said Section 35; thence, along said West line, S0°05'21"W 470.00 feet to the Southwest Corner of the NE 1/4 of the NE 1/4 of said Section 35, from which a 5/8 inch dia. rebar capped: MDL 4232S bears N0°05'21"E 185.00 feet, set as a Witness Corner; thence, along the South line of the NE 1/4 of the NE 1/4 of said Section 35, S89°44'42"E 1317.28 feet to the point of beginning.

The aforescribed Parcel "A" contains 20.003 acres, more or less.

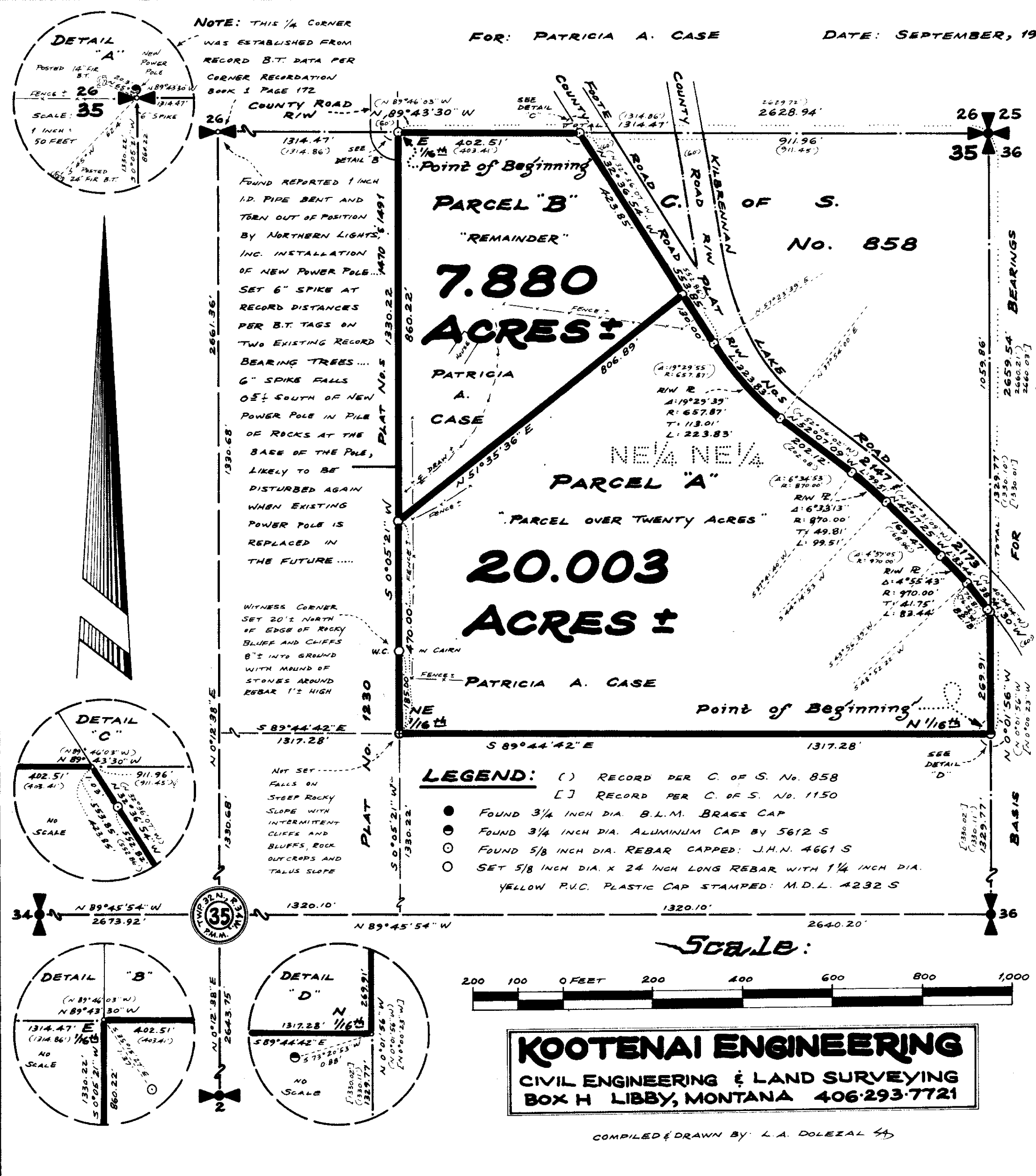

A tract of land near Troy in Lincoln County, Montana, lying within the NE 1/4 of the NE 1/4 of Section 35 Twp. 32N., R. 34W., P.M.M., more particularly described as follows:

Beginning at the Northwest corner of the NE 1/4 of the NE 1/4 of said Section 35, from which a 5/8 inch dia. rebar capped: JHN 4661S bears S35°15'27"E 1.37 feet; thence, along the west line of the NE 1/4 of the NE 1/4 of said Section 35, S0°05'21"W 860.22 feet to a 5/8 inch dia. rebar capped: MDL 4232S; thence, leaving said West line, N51°35'36"E 806.89 feet to a 5/8 inch dia. rebar capped: MDL 4232S on the Southwesterly right of way line of the Foote Road (a 60.00 foot wide County Road Right of Way per Plat No.s 2147 and 2173) at a distance of 30.00 feet measured at right angles from the centerline thereof; thence, along said Southwesterly right of way line, N32°36'54"W 423.85 feet to a point on the North line of said Section 35, from which a 5/8 inch dia. rebar capped: JHN 4661S bears S32°36'54"E 1.03 feet; thence, leaving said Southwesterly right of way line, along the North line of said Section 35, N89°43'30"W 402.51 feet to the point of beginning.
