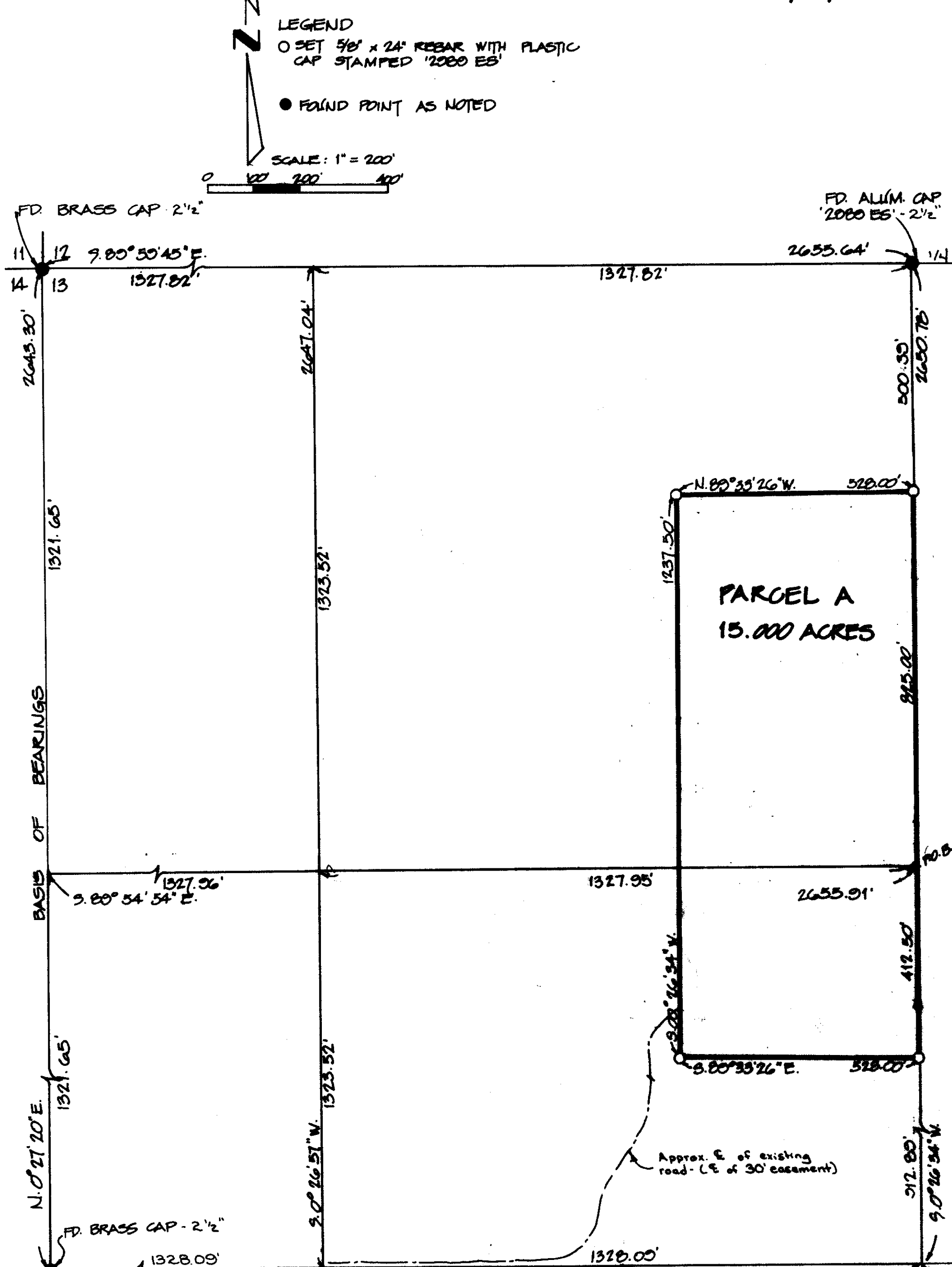

 BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4; THENCE ALONG THE EAST LINE OF THE SOUTHEAST 1/4 OF THE NORTHWEST 1/4 SOUTH 0°26'34" WEST 412.50 FEET; THENCE NORTH 89°33'26" WEST 528.00 FEET; THENCE NORTH 0°26'34" EAST 1237.50 FEET; THENCE SOUTH 89°33'26" EAST 528.00 FEET TO THE EAST LINE OF THE NORTHEAST 1/4 OF THE NORTHWEST 1/4; THENCE ALONG THE EAST LINE SOUTH 0°26'34" WEST 825.00 FEET TO THE POINT OF BEGINNING, CONTAINING 15.000 ACRES OF LAND, ALL AS SHOWN HEREON.
