DESCRIPTION PARCEL "A"-MORTGAGE PARCEL

A tract of land near Libby in Lincoln County, Montana, being a portion of Certificate of Survey No. 715 of Lincoln County, Montana records, lying within the W 1/2 of the SE 1/4 of Section 22 Twp. 28 N., R. 30 W., P.M.M., more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped: MDL 4232S on the North-South centerline of said Section 22 at a distance of 2000.00 feet N 0°11'05"W from a 3/4 inch dia. B.L.M. Brass Capped Monument marking the South 1/4 Corner of said Section 22; thence, from said point of beginning, leaving the North-South centerline of said Section 22, N 89°57'27"E 575.63 feet to a 5/8 inch dia. rebar capped: MDL 4232S on the Southwesterly right of way line of U.S. Highway No. 2 at a distance of 40.00 feet measured at right angles from the centerline thereof; thence, along said Southwesterly right of way line, S 10°19'15"E 186.23 feet to a 5/8 inch dia. rebar capped: MDL 4232S at reported centerline station 251+50; thence, S 79°04'45"W 40.00 feet to a 5/8 inch dia. rebar capped: MDL 4232S at a distance of 80.00 feet measured at right angles from said centerline; thence, along said Southwesterly right of way line, S 10°19'15"E 300.00 feet to a 5/8 inch dia. rebar capped: MDL 4232S at reported centerline station 254+50; thence, leaving said Southwesterly right of way line, S 89°57'27"W 621.82 feet to a 5/8 inch dia. rebar capped: MDL 4232S on the North-South centerline of said Section 22; thence, along said North-South centerline, N 0°11'05"W 485.57 feet to the point of beginning.

The aforescribed Parcel "A" contains 6.622 acres, more or less, and is SUBJECT to a 30.00 Foot Wide Easement along an Existing Access Road crossing the Northeastly corner thereof, generally as delineated hereon and on Certificate of Survey No. 715.

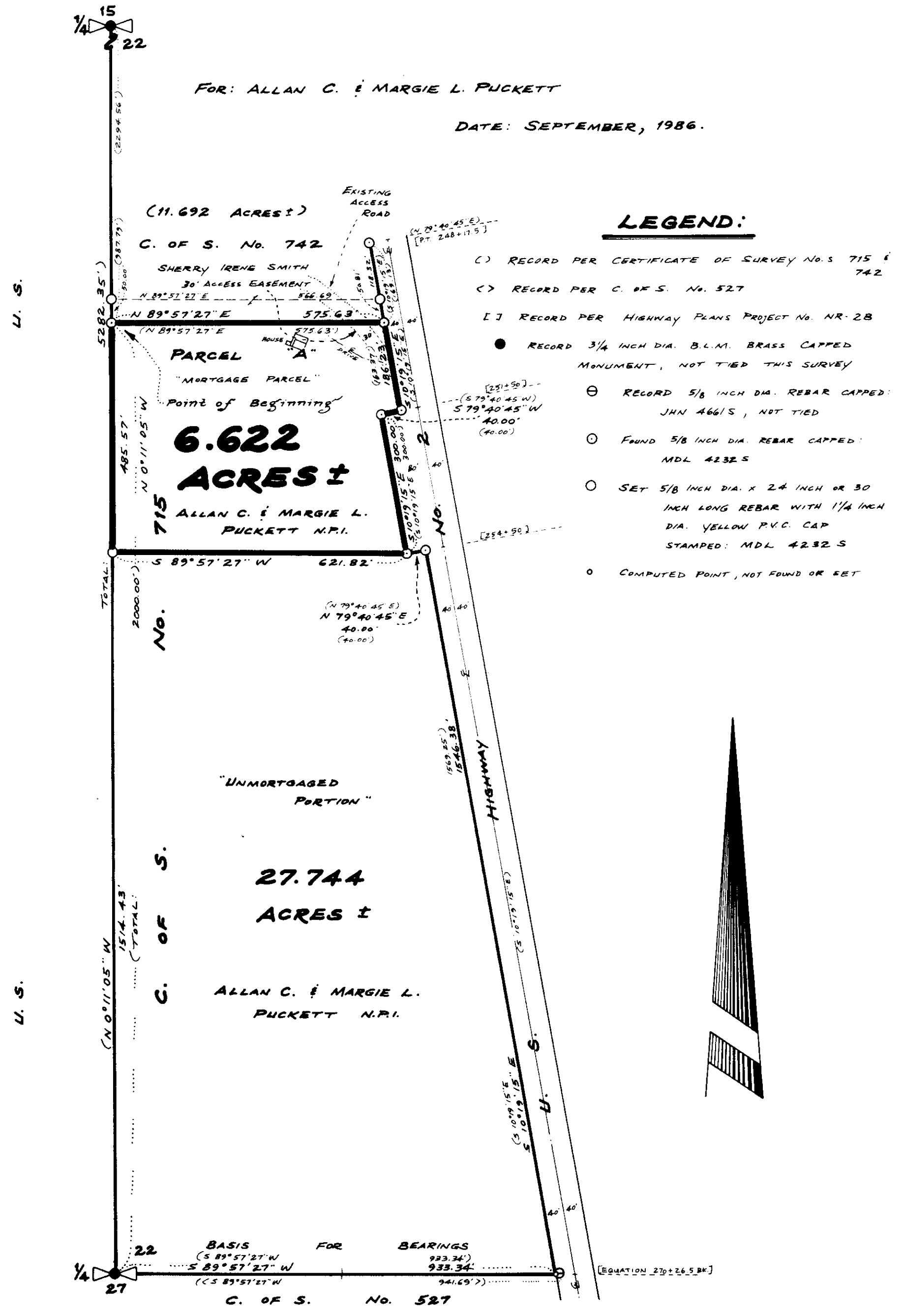
