Beginning at a 5/8 inch dia. rebar capped: KED 4975 S on the East-West centerline of said Section 19 at a distance of 714.81 feet S 89°28'57" E from a 3/4 inch BLM Brass Cap marking the West 1/4 Corner of said Section 19; thence, from said point of beginning leaving said East-West Centerline S 29°11'58" W 63.59 feet to a 5/8 inch dia. rebar capped: KED 4975 S; thence, S 66°32'36" E 79.20 feet to a 5/8 inch dia. rebar capped: KED 4975 S; thence, N 59°27'57" E 168.00 feet to a 5/8 inch dia. rebar capped: KED 4975 S located on the East-West centerline of said Section 19; thence, along said East-West centerline N 89°28'57" W 186.35 feet to the point of beginning.

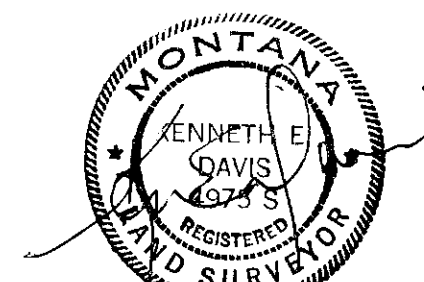

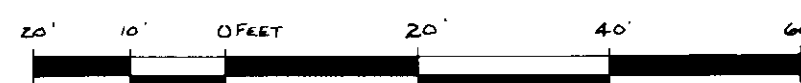
