

Forest Supervisor's Certificate

This Survey was made at my request for National Forest management purposes.

Purpose of Survey

The purpose of this survey is to locate upon the ground, the title lines of record between private lands and National Forest System Lands. No division of land is hereby created.

Method of Survey

A Leitz Set 2 Total Station with an Electronic Field Book was used for this survey. The section was controlled using conventional closed traverse procedures to tie appropriate controlling corners and offsets computed.

Basis of Bearing

The bearing for this Certificate of Survey is based upon the Preliminary NAD 83 geodetic azimuth, 302°01'02", from "Cherry Azimuth Mark" to NGS Station "Cherry". These 1986 stations were established by N.G.S. using a Global Positioning System.

Surveyor's Notes

The geographic postions for Stations "Cherry" and "Cherry Azimuth Mark" are . 48°10'52.3" Latitude and 115°32'40.4" Longitude and 48°10'01.1 Latitude and 115°30'37.9" Longitude respectively, as provided by N.G.S. The geographic position for the west 1/4 corner of section 31 was derived from a direct tie from "Cherry Azimuth Mark".

The Hansen and the Raven Placers are identical, as are the C and F and Missoula Placers.

This survey conforms to the USFS Region One Cadastral Survey Contract Specifications.

Corner Recordation forms for each corner shown hereon are on file with the Clerk and Recorder, Lincoln County Courthouse, Libby, Montana.
