Purpose of Survey

The purpose of this survey is to locate upon the ground the title line of record between National Forest System lands and private lands, and no division of land is hereby created.

History

1893, original survey of the south boundary of section 33, the 8th Standard Parallel by McCardell et al.
1903, original township subdivision survey by Rinearson et al.
1960 and 1961, B.L.M. remonumentation by Stephens et al.
1981, adjacent section 28 was surveyed under a U.S.D.A. Forest Service contract and Certificate of Survey No. 1034 was filed by S. Smith, 4740-S.
1982, adjacent section 34 was surveyed by U.S.D.A. Forest Service and Certificate of Survey No. 1095 was filed by T. Hill, 5612-S.
1983, section subdivision survey, U.S.D.A. Forest Service corner recordations filed by T. Hill, 5612-S.

Survey Note

Review of project records showed no Certificate of Survey for section 33 filed. This Certificate of Survey is therefore filed to clear record.

Corner positions as shown on this survey are based upon closed traverses performed with a theodolite-EDM instrument.

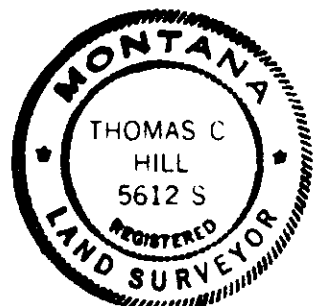
Basis of Bearings
