

PURPOSE OF SURVEY

The purpose of this survey is to locate upon the ground, the title lines of record between private lands and National Forest System Lands. Therefore, no division of land is hereby created.

HISTORY

1893 Original G.L.O. survey of Fractional T. 31 N., R. 33 W., which includes Section 22 by Daniel P. Mumbrue

1965 and 1968 B.L.M. Remonumentation by Duane G. Lindenberg (West boundary of Section 22) and Woodrow E. Damm et. al. (remainder of B.L.M. remonumented corners)

1981 Certificate of Survey No. 869 by Jack H. Ninneman, 4661S, Subdividing Sections 15 and 16. Monumentation of the W 1/16 Corner between Sections 15 and 22.

SURVEYOR'S NOTES

Two re-bar with yellow plastic caps stamped JHN 4661S, as shown on this Certificate of Survey, were found on the West boundary of Section 22. No record of these could be found in the records of Lincoln County. The position of the W 1/16 between Sections 15 and 22 as monumented by Jack H. Ninneman in 1981 was accepted and remonumneted with a Forest Service monument. Reference should be made to Certified Corner Recordation Forms on file with Lincoln County Clerk and Recorder.

LEGAL DESCRIPTION

National Forest System Lands defined hereon: W 1/2 NW 1/4 and W 1/2 SW 1/4 Section 22, T. 31 N., R. 33 W.

SURVEY METHOD

Corner positions as shown by this survey are based upon closed traverses performed with a total station instrument, November 1987 and May 1988.

BASIS OF BEARING

Solar observation taken near the One-Quarter corner of Sections 22 and 27, T. 31 N., R.33 W.
