C.O.S. No. 1031, 1982.

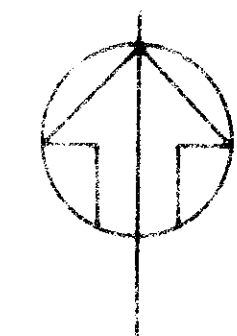
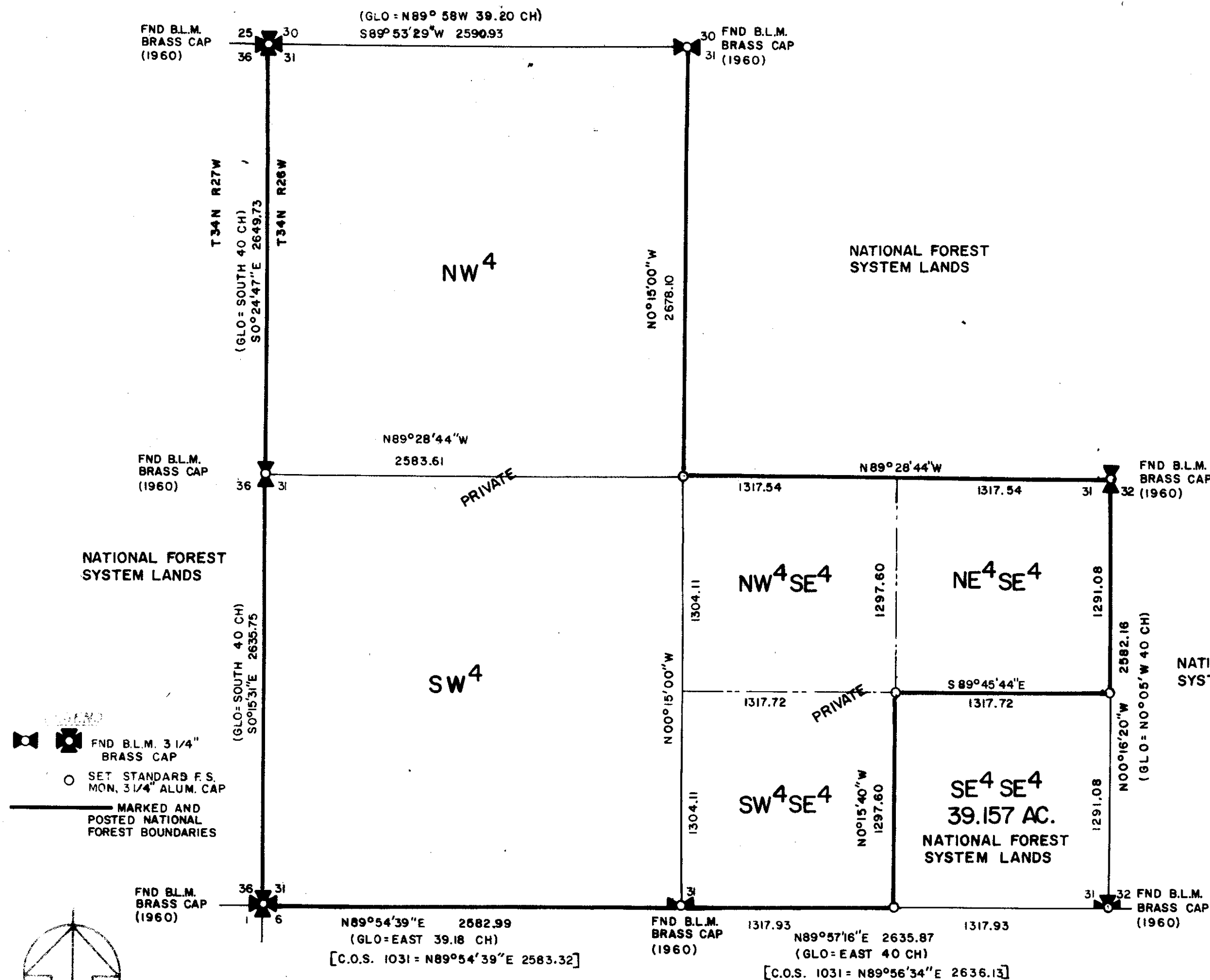
