

CERTIFICATE OF SURVEY

DESCRIPTION PARCEL "A"

A tract of land near Libby in Lincoln County, Montana, being a part of Certificate of Survey No. 1243 designated Parcel "B" of Lot 4 of Dahling Tracts and reported to lie within the SE2 of the Nw2 of Section 36, Twp. 30 N, R 31 W, P.M.M., containing 0.1451 acre, more or less, and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped: MDL 4232 S on the East line of C. of S. No. 1243; thence, along said East line S 0°01'30" E 20.00 feet to a 5/8 inch dia. rebar capped: KED 4975 S; thence, leaving said East line S 89°51'41" W 315.82 feet to a 5/8 inch dia. rebar capped: KED 4975 S on the East right-of-way line of Montana State Highway Project S 325-(1); thence, along the West line of said C. of S. No. 1243 and said East right-of-way line N 0°42'49" W 20.00 feet to a 5/8 inch dia. rebar capped: MDL 4232 S; thence, leaving said West line and said Easterly right-of-way line N89°51'41" E 316.06 feet to the point of beginning.



We hereby certify that the purpose of this division of land is to create a parcel to be used for a roadway, and no structures requiring water or sewage disposal will be erected on the parcel so created. Therefore, this division is exempt from review by the Department of Health and Environmental Sciences pursuant to ARM 16.16.605(2)(e). We hereby certify that the purpose of this division of land is to relocate a common boundary line between adjoining properties outside a platted subdivision and that no additional parcels are hereby created. Therefore, this division of land is exempt from review as a subdivision pursuant to section 76-3-207(1)(a), MCA.
