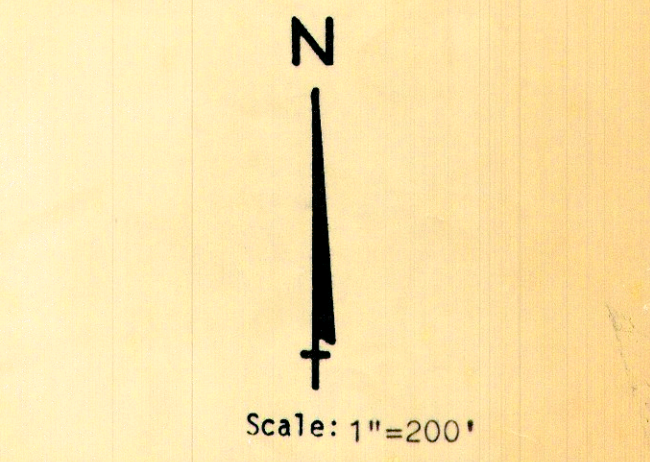
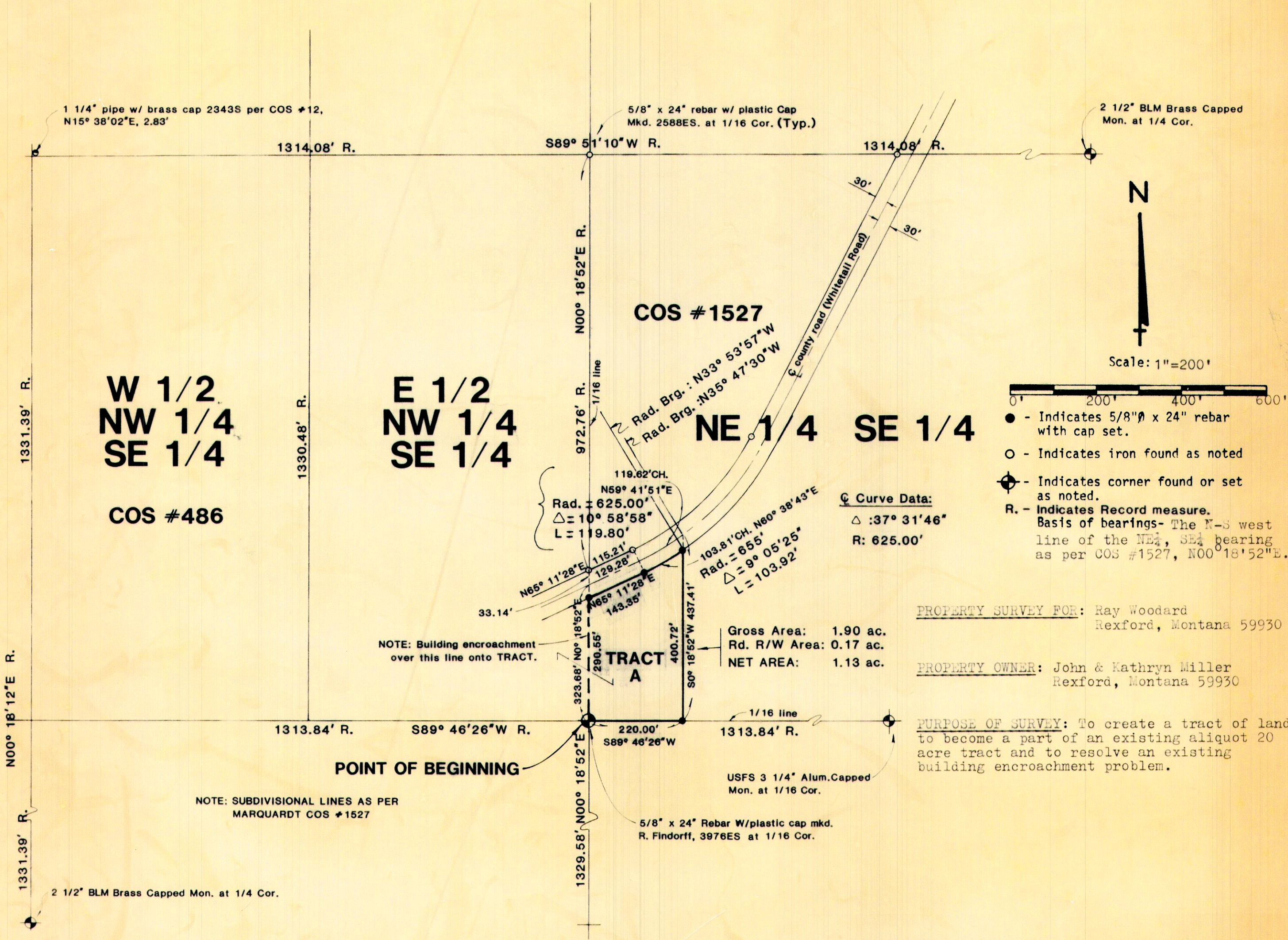


CERTIFICATE OF SURVEY

PURPOSE OF SURVEY: To create a tract of land to become a part of an existing aliquot 20 acre tract and to resolve an existing building encroachment problem.

DESCRIPTION OF TRACT A: All that part of the NE 1/4 of the SE 1/4, Section 15, T37N, R28W, P.M.M., Lincoln County, Montana, described as commencing at the SW corner of said NE 1/4, SE 1/4; thence N00°18'52"E 323.68 feet along the 1/16 line to the centerline of a country road; thence N65°11'28"E 129.28 feet to the P.C. of a curve to the left with a radius of 625.00 feet and a delta angle of 10°58'58"; thence along said curve 119.80 feet with a chord of 119.62 feet bearing N59°41'51"E; thence S0°18'52"W 437.41 feet to the E-W 1/16 line; thence S89°46'26"W 220.00 feet to the Point of Beginning. Said tract contains 1.90 acres with 0.17 acres being county road right-of-way.

CERTIFICATE OF EXEMPTION

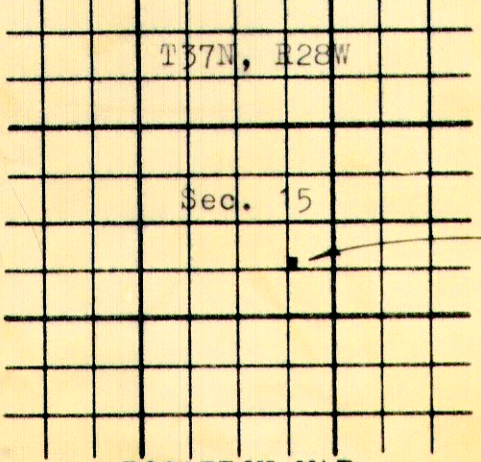
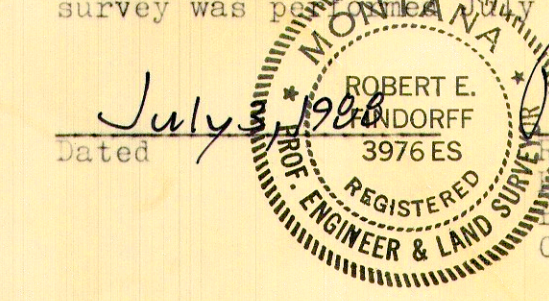
