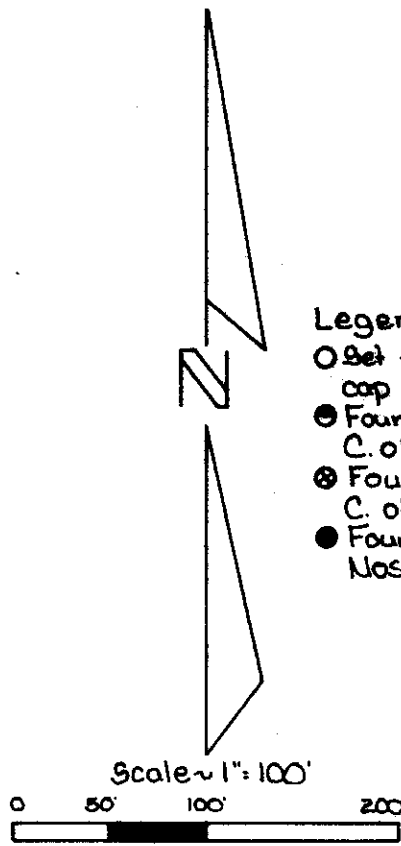

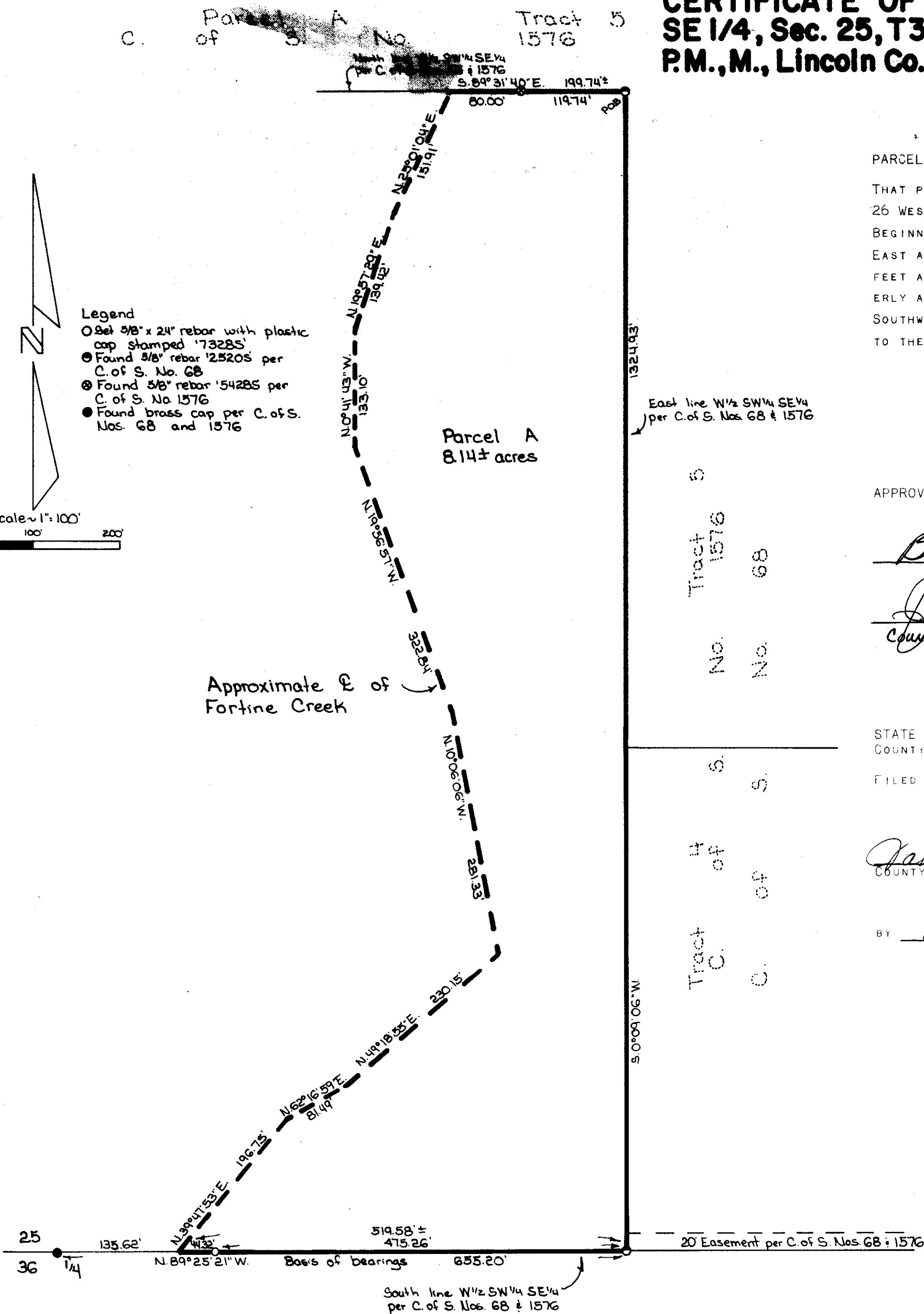
LEGAL DESCRIPTION

BEGINNING AT THE NORTHEAST CORNER OF THE WEST 1/2 OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4; THENCE ALONG THE EAST AND SOUTH LINES OF THE WEST 1/2 OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4 SOUTH 0°09'06" WEST 1324.93 FEET AND NORTH 89°25'21" WEST 520 FEET MORE OR LESS TO THE CENTERLINE OF FORTINE CREEK; THENCE NORTHEAST-ERLY AND NORTHERLY ALONG THE CENTERLINE 1537 FEET MORE OR LESS TO THE NORTH LINE OF THE WEST 1/2 OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4; THENCE ALONG THE NORTH LINE SOUTH 89°31'40" EAST 200 FEET MORE OR LESS TO THE POINT OF BEGINNING CONTAINING 8.14 ACRES OF LAND ALL AS SHOWN HEREON.
