

## PURPOSE OF SURVEY:

The purpose of this survey is to locate upon the ground, the title lines of record between private and National Forest Lands. No division of land is hereby created.

### METHOD OF SURVEY:

Conventional total station traverse procedures were used to accomplish this survey from this data, corner moves and posting offsets were computed.

#### BASIS OF BEARING:

Computed from record State Plane Coordinate values for station "Sheldon" (U.S.C. and G.S. established) and stations "flat", "gravel", "range", and "sand" (B.P.A. established) then rotated to true meridian (-4°31'47") about the 1/4 corner of section 4 and 9.

#### LEGAL DESCRIPTION:

National Forest Lands described hereon - NW1/4 SW1/4, NE1/4 SW1/4, and SE1/4 SW1/4. Private Lands described hereon - SW1/4 SW1/4.

Montana State Plane Coordinate System (North Zone) computed values for 1/4 section 4 and 9, Y=594,844., X=529,411., latitude 48'28'16"N, longitude 115°35'14"W. The combined scale factor is 0.99985793.
