

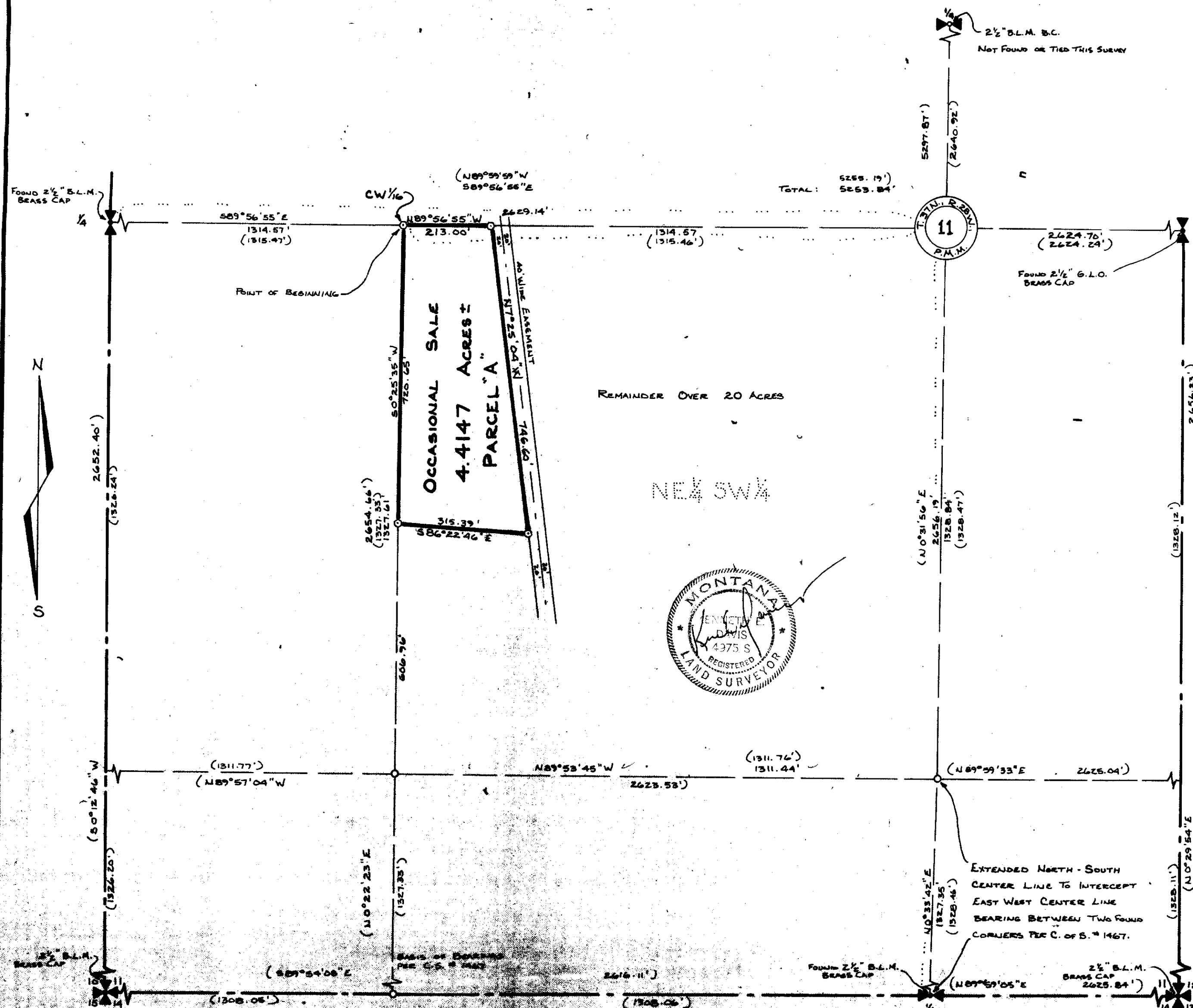

DESCRIPTION PARCEL "A"

A tract of land near Rexford in Lincoln County, Montana, lying within the NE 1/4 of the SW 1/4 of Section 11, Twp. 37 N., R. 28 W., P.M.M., containing 4.4147 acres, more or less, and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped: KED 4975 S marking the CW 1/16 Corner of said Section 11, a distance of 1314.57 feet S 89°56'55" E from the BLM Brass Capped Monument marking the West 1/4 Corner of said Section 11; thence, from said point of beginning along the West line of the NE 1/4 of the SW 1/4 of said Section 11, S 0°25'35" W 720.65 feet to a 5/8 inch dia. rebar capped: KED 4975 S; thence, leaving said West line, S 86°22'46" E 315.39 feet to a 5/8 inch dia. rebar capped: KED 4975 S on the Westerly line of a 40.00 foot wide easement known as "Basin Drive"; thence, along said Westerly easement line N 7°25'04" W 746.60 feet to a 5/8 inch dia. rebar capped: KED 4975 S on the East-West Centerline of said Section 11; thence, leaving said Westerly line along said East-West Centerline N 89°56'55" W 213.00 feet to the point of beginning.

PURPOSE OF SURVEY/EXEMPTION CERTIFICATION

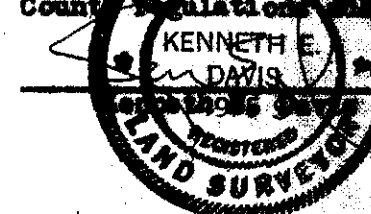
