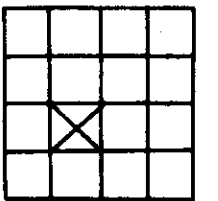

PURPOSE: Retracement of a tract of record

TRACT 1
LEGAL DESCRIPTION

A tract of land, situate, lying and being in the NE 1/4 SW 1/4 of Section 11, Township 36 North, Range 27 West, P.M.M., Lincoln County, Montana, and more particularly described as follows:

Commencing at a point of intersection with the easterly R/W of U.S. Highway 93 and the south line of said NE 1/4 SW 1/4; thence N 00° 39' 00" E along the easterly R/W of U.S. Highway 93, 860.00 feet to the true point of beginning of the tract being described; thence continuing N 00° 39' 00" E along said R/W, 271.60 feet to a point; thence leaving said R/W, N 89° 14' 30" E a distance of 300.00 feet; thence S 00° 39' 00" W, 271.60 feet; thence S 89° 14' 30" W, 300.00 feet to the point of beginning and containing 1.870 acres of land.
