

## CERTIFICATE OF SURVEY

in the W1/2 of the SW1/4 SECTION 34, TOWNSHIP 31 NORTH RANGE 31 WEST, P.M.M. LINCOLN COUNTY, MONTANA

### DESCRIPTION - PARCEL "A"

A tract of land in the West Half of the Southwest Quarter (W1/2 SW1/4) of Section Thirty-four (34), Township Thirty-one (31) North, Range Thirty-one (31) West, P.M.M., Lincoln County, Montana; more particularly described as follows:

Commencing at a point on the west line of the SW1/4 of said Section 34 which is N 00°00'11' W 992.19 feet from the southwest corner of said SW1/4; thence N 89°59'49" E 853.90 feet to a point on the northerly right-of-way of the county road known as Kootenai River Road marked by a 5/8" rebar capped "JRS 9958S"; thence along said right-of-way on a curve to the right having a radius of 4700.00 feet and a central angle of 03°01'35" (chord = N 73°12'09" W 248.22) for an arc distance of 248.25 feet to a 1/2" pipe marked "W&R 42325" being the southeast corner of Certificate of Survey No. 141; thence along the east boundary of said C.S. No. 141 N 00°00'37" E 194.89 feet to a 1/2" pipe marked "W&R 42325"; thence N 00°00'37" E 147.97 feet to a 5/8" rebar capped "JRS 9958S"; thence on a curve to the left having a radius of 60.00 feet and a central angle of 60°18'24" (chord = N 62°55'34" E 60.28 feet) for an arc distance of 63.15 feet to a 5/8" rebar capped "JRS 9958S"; thence S 69\*56'00" E 195.85 feet to a 5/8" rebar capped "JRS 9958S"; thence S 00"00'37" W 374.83 feet to the TRUE POINT OF BEGINNING; encompassing an area of 2.06 acres.

#### DESCRIPTION - REMAINDER

A tract of land in the West Half of the Southwest Quarter (W1/2 SW1/4) of Section Thirty~four (34), Township Thirty-one (31) North, Range Thirty-one (31) West, P.M.M., Lincoln County, Montana; more particularly described as follows:

Commencing at a point on the west line of the SW1/4 of said Section 34 which is N 00°00'11" W 992.19 feet from the southwest corner of said SW1/4; thence N 89\*59'49" E 853.90 feet to a point on the northerly right-of-way of the county road known as Kootenai River Road marked by a 5/8" rebar capped "JRS 9958S"; thence along said right-of-way on a curve to the left having a radius of 4700.00 feet and a central angle of 05°34'42" (chord = S 77°30'17" E 457.41 feet) for an arc distance of 457.59 feet to a 5/8" rebar capped "MDL 4232S" being the southwest corner of Certificate of Survey No. 636; thence along the west boundary of said C.S. No. 636 for the following three courses: N 01°04'39" W 368.12 feet to a 5/8" rebar capped "MDL 42325"; thence on a curve to the right having a radius of 530.00 feet and a central angle of 06°36'05" for an arc distance of 61.06 feet to a 5/8" rebar capped "MDL 42325"; thence N 05\*31'31" E 117.85 feet to the southeast corner of the First Addition to Kootenal Heights Subdivision being marked by a 5/8" rebar capped "MDL 4232S";

thence along the southerly boundary of said Subdivision N 67°32'27"W 765.35 feet to the northeast corner of Kootenai Heights Subdivision being marked by a 1/2" rebar; thence along the east boundary of said Subdivision S 00°00'20" E 208.54 feet to a 5/8" rebar capped "JRS 9958S"; thence on a curve to the right having a radius of 60.00 feet and a central angle of 141°48'43" (chord = \$38°08'00" E 113.40 feet) for an arc distance of 148.51 feet to a 5/8" rebar capped "JRS 9958S"; thence S 69°56'00" E 195.85 feet to a 5/8" rebar capped "JRS 9958S"; thence S 00°00'37" W 374.83 feet to the TRUE POINT OF BEGINNING; encompassing an area of 7.50 acres.

#### EXEMPTION CERTIFICATE

This division of land was created by court order, Probate Number DP-90-22, and is therefore exempt from review as a subdivision pursuant to Section 76-3-201(1), MCA, and further exempt from review by the Department of Health and Environmental Sciences pursuant to ARM 16-16.605(1)(a).

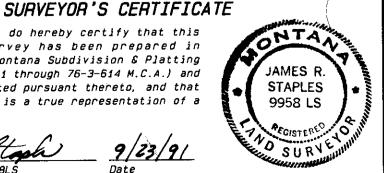
