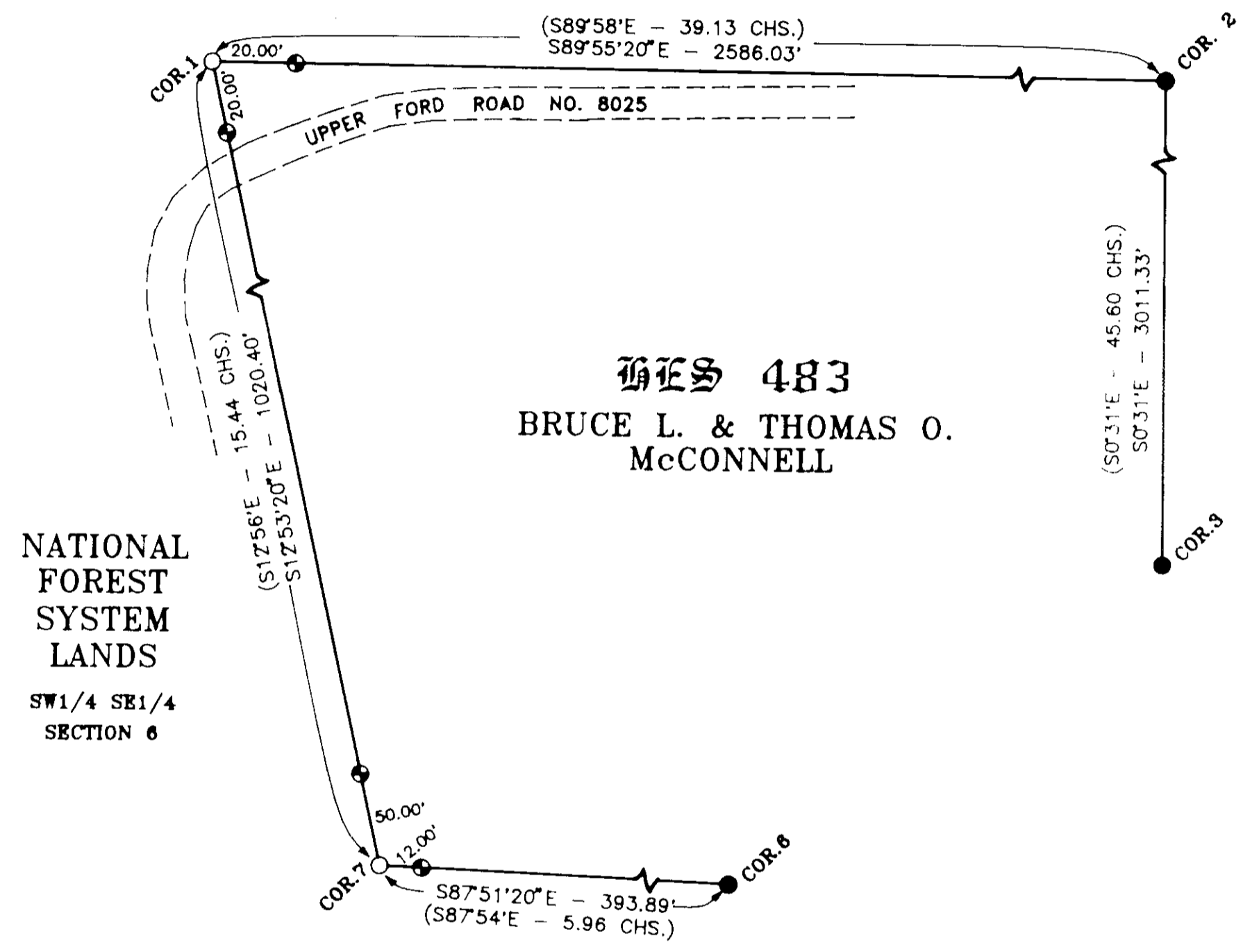
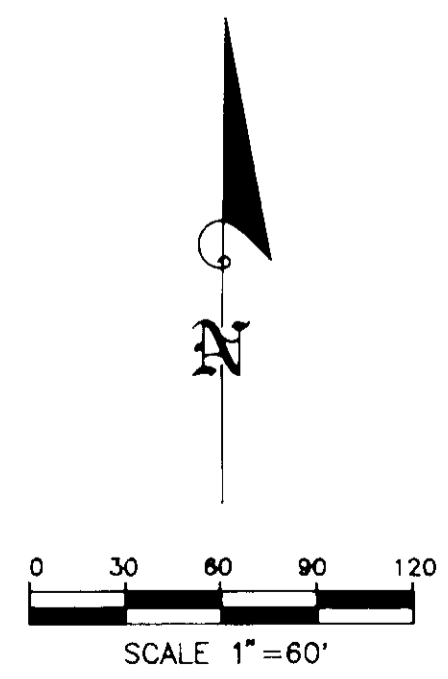

PURPOSE OF SURVEY:
 The purpose of the survey is to locate upon the ground, lines between the Private Land of HES 483 and National Forest Systems Lands. No division of land is hereby created.

METHOD OF SURVEY:
 A one second Lietz Total Station was used to control the original H.E.S. corners and offsets were calculated to true line.

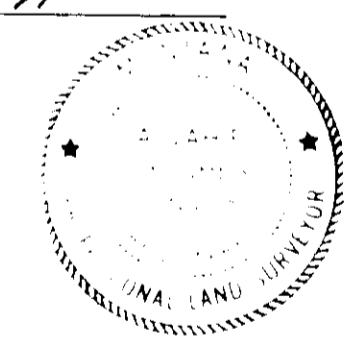
BASIS OF BEARING:
 The basis of bearing is the H.E.S. 483 record bearing between corners 2 and 3, S0°31'E.

HISTORY OF SURVEY:
 1915 H.E.S. 483 by Fred E. Thieme.

SURVEYOR'S NOTES:
 The H.E.S. 483 property lines were needed for acquisition of a county road Right-of-Way. The original corner positions for corners 1 and 7 fall in channels of the Yaak River and are lost. I used the Grant Boundary Method of proportion to reestablish these corner positions, by tying the original H.E.S. corners 2, 3 and 6. Refer to Corner Recordations filed Lincoln County Courthouse, for corners shown hereon. Right-of-Way plat and deeds filed separately.
