

**PURPOSE OF SURVEY**

The purpose of this survey is to locate upon the ground, the title lands of record between private and National Forest Lands. No division of land is hereby created.

**METHOD OF SURVEY:**

This survey was accomplished by triangulation - trilateration control traverse and Conventional total station traverse procedures. From this data, corner move was computed.

**BASIS OF BEARING:**

1984 Control, solar observation

**LEGAL DESCRIPTION:**

Private lands described hereon - NE 1/4 Sec. 33.

**SURVEYOR'S NOTES:**

The north 1/4 corner, east 1/4 corner and south 1/4 corner of section 33 was surveyed and tied to an existing control network established by U.S. Forest Service in 1984. The same control was used to subdivide section 32 in 1985. Previous survey ties to west 1/4 section 33 were used per 1985 survey of section 32.
