

A tract of land lying in Government Lot 6, Section 24, Township 27 North, Range 28 West, Principal Meridian, Montana, in the county of Lincoln, State of Montana, more particularly described as follows: Commencing at the north meander corner of said section 24 on the north shoreline of Crystal Lake, a 1-1/2 inch diameter aluminum capped monument, marked 2927-ES 1991, and Corner 1-C: thence along the East section line of section 24, which bears N00°00'00"E, a distance of 368.92 feet to Corner 2-C, an unmarked 1/2 inch iron rod monument; thence along a line which bears \$9000000"W, a distance of 203.10 feet to Corner 3-C, a 1 inch plastic capped monument, marked Pearson 9008LS; thence along a line which bears N08°58'12"E, a distance of 66.80 feet to Corner 1-B, an unmarked 1/2 inch rebar monument; thence along a line which bears N08°22'40"E, a distance of 63.22 feet to the True Point of Beginning and Corner 1-A, an unmarked 1/2 inch rebar monument; thence along a line which bears N08°52'51"E, a distance of 45.32 feet to Corner 2-A, an unmarked 1/2 inch rebar monument; thence along a line which bears \$89038'00"W, a distance of 297.46 feet to Corner 3-A, a 1 inch plastic capped monument, marked Pearson 9008LS; thence along the meander line of Crystal Lake which bears \$24°38'44"E, a distance of 49.07 feet to Corner 2-B, a 1 inch plastic capped monument, marked Pearson 9008LS; thence along a line which bears N89°38'00"E, a distance of 270.00 feet to Corner 1-A, as described and the True Point of Beginning, containing 0.29 acres.

A tract of land lying in Government Lot 6, Section 24, Township 27 North, Range 28 West, Principal Meridian, Montana, in the county of Lincoln, State of Montana, more particularly described as follows: Commencing at the north meander corner of said section 24 on the north shoreline of Crystal Lake, a 1-1/2 inch diameter aluminum capped monument, marked 2927-ES 1991, and Corner 1-C: thence along the East section line of section 24, which bears N0000000 E, a distance of 368.92 feet to Corner 2-C, an unmarked 1/2 inch iron rod monument; thence along a line which bears \$90000000 W, a distance of 203.10 feet to the True Point of Beginning and Corner 3-C, a 1 inch plastic capped monument, marked Pearson 9008LS; thence along a line which bears N08°58'12"E, a distance of 66.80 feet to Corner 1-B, an unmarked 1/2 inch rebar monument; thence along a line which bears N08<sup>o</sup>22'40"E, a distance of 63.22 feet to Corner 1-A, an unmarked 1/2 inch rebar monument; thence along a line which bears \$89\(^{9}38'00''\)W, a distance of 270.00 feet to Corner 2-B, a 1 inch plastic capped monument., marked pearson 9008LS; thence along the meander line of Crystal Lake which bears \$20\dagged 3'06"E, a distance of 40.97 feet to an unmarked angle point; thence continuing along said-meander line which bears \$28057'17"E, a distance of 59.18 feet to an unmarked angle point; thence continuing along said meander line which bears \$36°30'52"E, a distance of 30.82 feet to Corner 4-C, a 1 inch plastic capped monument, marked Pearson 9008LS; thence along the new boundary line which bears \$86°23'16"E, a distance of 189.26 feet to Corner 3-C, as described and the True Point of Beginning, containing 0.65 acres.



# PURPOSE OF SURVEY

The purpose of this survey is to retrace existing property lines as shown on Plats No. 1125, 1806 and 2268, and to relocate a common property line between existing Parcel "B" and "C", under Relocation of Common Boundaries Exemption requested by Mr. Arthur N. Skogas, owner of record.

#### METHOD OF SURVEY

This survey was accomplished with a theodolite-EDM traverse, July 1991, by Ronald Pearson, 9008-LS and Alvah Hughes, 7322-LS.

#### BASIS OF BEARING

Bearing are based on the section line bearing of Section 24, per Certificate of Survey No. 1806, which bears North from Meander Corner.
