 BEGINNING AT THE EAST $\frac{1}{4}$ CORNER OF SECTION 11; THENCE ALONG THE EAST LINE OF THE SOUTHEAST $\frac{1}{4}$, SECTION 11 SOUTH $0^{\circ}08'03''$ EAST 470.29 FEET TO A POINT ON THE NORTHERLY LINE OF STATE HIGHWAY NO. 37 WHICH POINT IS ON A 1528.35 FOOT RADIUS CURVE CONCAVE SOUTHERLY HAVING A RADIAL BEARING OF SOUTH $24^{\circ}59'13''$ EAST; THENCE ALONG THE NORTHERLY LINE OF THE HIGHWAY SOUTHWESTERLY ALONG THE CURVE THRU A CENTRAL ANGLE OF $07^{\circ}10'12''$ 191.26 FEET; THENCE NORTH $0^{\circ}06'48''$ WEST 563.50 FEET TO THE NORTH LINE OF THE SOUTHEAST $\frac{1}{4}$; THENCE ALONG THE NORTH LINE SOUTH $89^{\circ}23'13''$ EAST 167.88 FEET TO THE POINT OF BEGINNING CONTAINING 1.984 ACRES OF LAND ALL AS SHOWN HEREON.

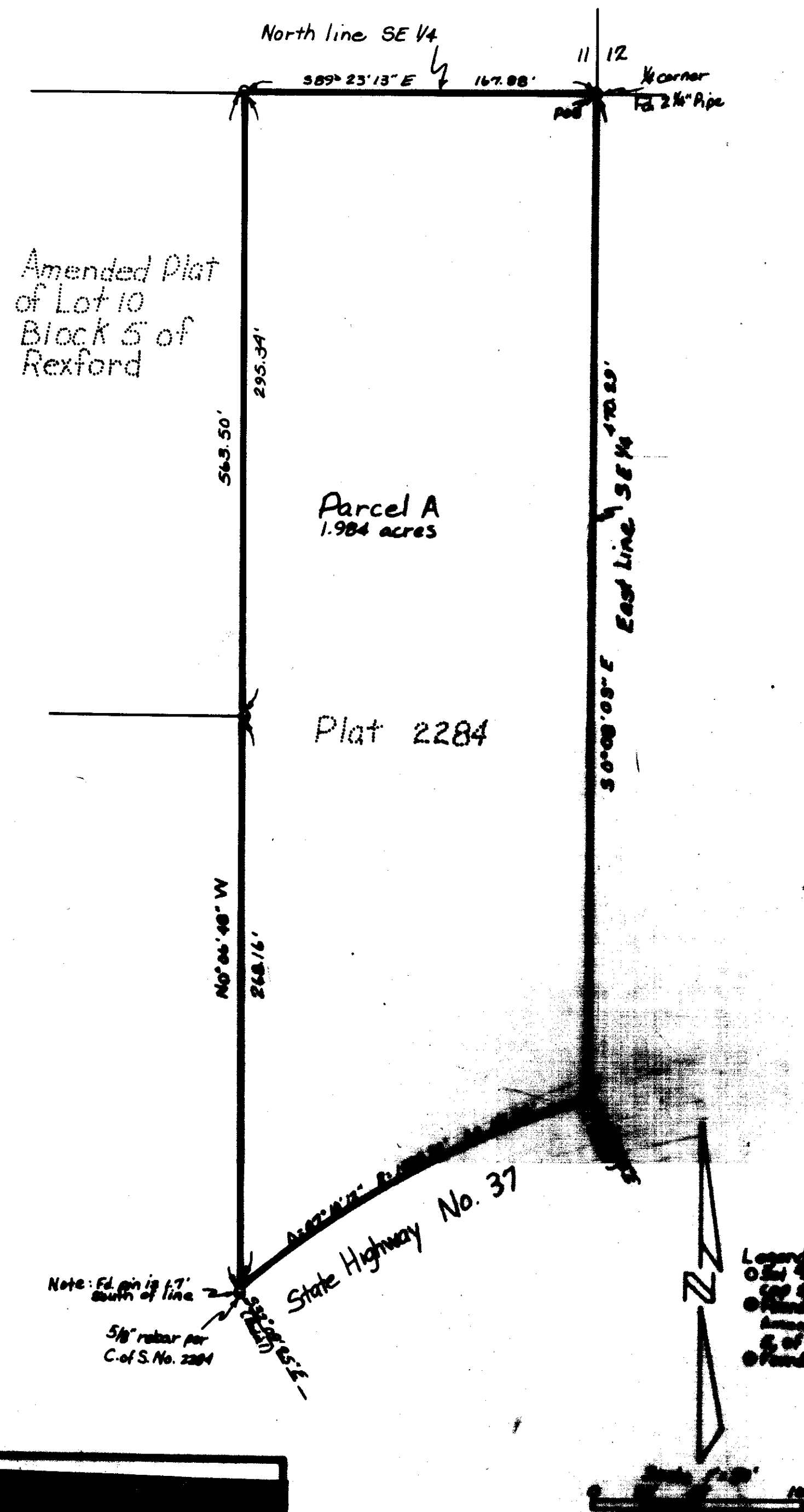
