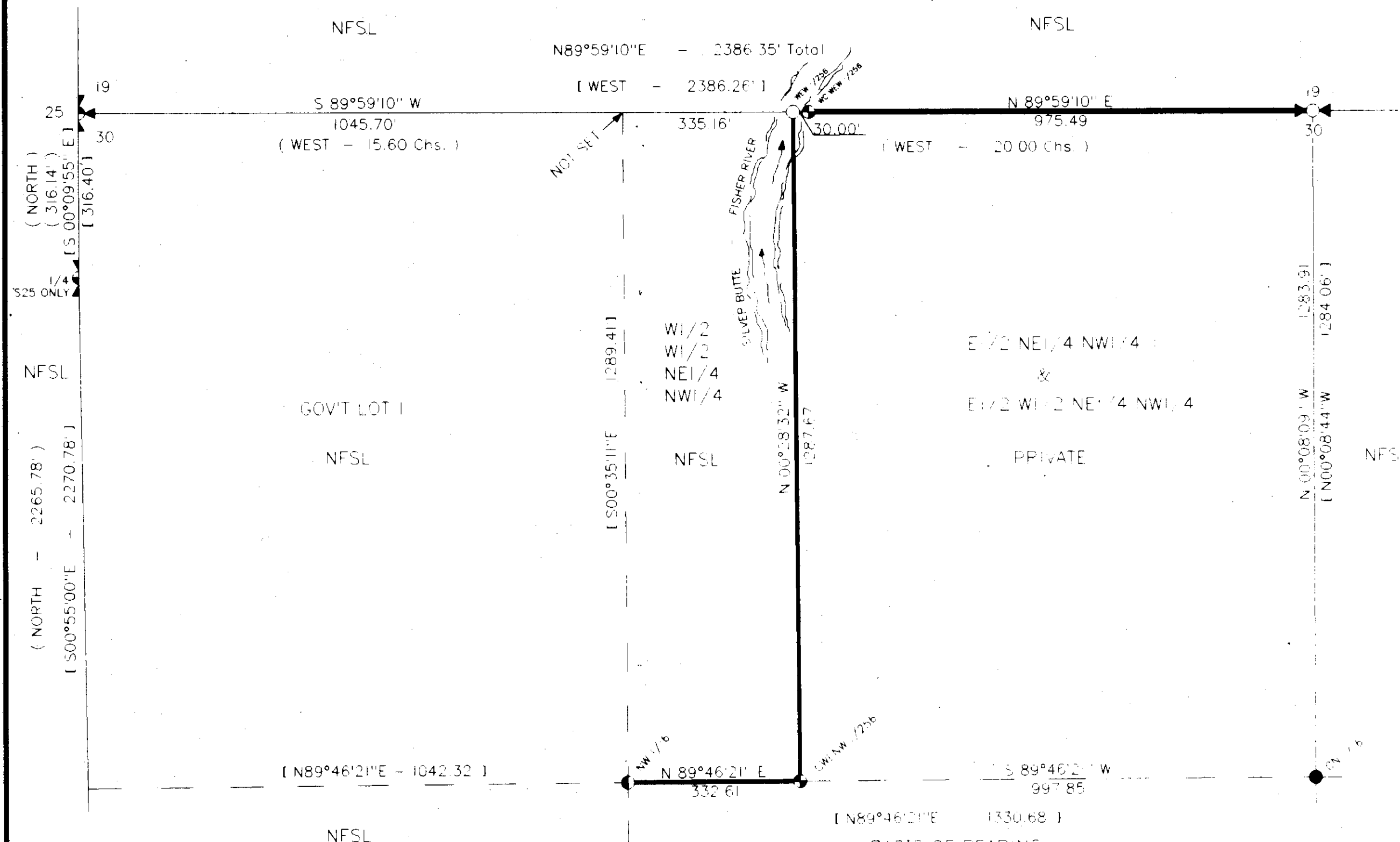

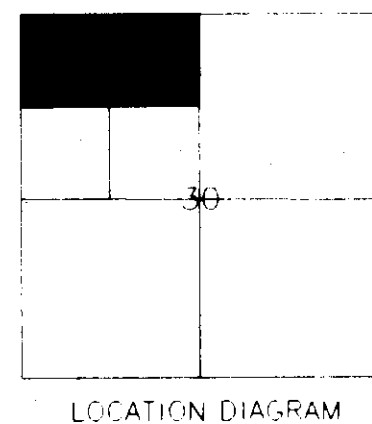

PURPOSE OF SURVEY

The purpose of this survey is to locate upon the ground, the title lines of record between Private and National Forest Lands. No division of land is hereby created.

METHOD OF SURVEY

A one second Total Station and Data Collector was used with closed traverse procedures to tie original controlling corners. The location of the monuments set this survey, meet the positional tolerance standard referenced in the USDA, Forest Service, Region One, Cadastral Contract Specification Manual, dated March 1987.

BASIS OF BEARING

Bearings are based on Certificate of Survey #1330A, dated September, 1992 by D. Marquardt, 2989ES.
