

DESCRIPTION OF PARCEL "A"

A tract of land near Libby in Lincoln County, Montana, being a part of Gov't Lots 2 and 3 of Section 30, Twp. 31 N, R. 31 W, P.M.M., and more particularly described as follows:

Beginning at a found 5/8 inch dia. rebar capped: KED 4975-S per C. of S. No. 1702 marking the southwesterly corner thereof; thence, from said point of beginning along the westerly line of said C. of S. No. 1702 N 31°00'44" E 545.79 feet to a 5/8 inch dia. rebar capped: KED 4975-S set as a witness corner on the left bank of the Kootenai River; thence, continuing along said line N 31°00'44" E 43.04 feet to the GLO meander line for a total dist. of 588.83 feet; thence, along the GLO meander line upstream S 62°30'00" E 123.09 feet; thence, S 30°30'00" E 373.42 feet; thence, leaving said GLO line S 51°02'07" W 61.86 feet to a 5/8 inch dia. rebar capped: KED 4975-S set as a witness corner; thence, continuing along said line S 51°02'07" W 383.31 feet for a total distance of 445.17 feet to a 5/8 inch dia. rebar capped: KED 4975-S located on the northerly Right-of-Way line of Burlington Northern Railroad which measures 100.00 feet from the centerline thereof; thence, N 58°59'17" W 298.64 feet to the point of beginning.

The above described tract of land contains 4.762 acres, more or less, and is subject to a 40 foot long x 50 foot wide septic easement to be utilized by Parcel "B", all as shown hereon.

A tract of land near Libby in Lincoln County, Montana, being a part of Gov't Lots 2 and 3 of Section 30, Twp. 31 N, R. 31 W, P.M.M., and more particularly described as follows:

Beginning at a found 5/8 inch dia. rebar capped: KED 4975-S per C. of S. No. 1702 marking the southeasterly corner thereof; thence, from said point of beginning along the southerly line of said C. of S. No. 1702 N 49°15'33" E 334.91 feet to a 5/8 inch dia. rebar capped: KED 4975-S set as a witness corner on the left bank of the Kootenai River; thence, continuing along said southerly line N 49°15'33" E 50.88 feet for a total distance of 385.84 feet to the GLO meander line N 30°30'00" W 108.75 feet; thence, leaving said meander line S 51°02'07" W 61.86 feet to a 5/8 inch dia. rebar capped: KED 4975-S set as a witness corner; thence, continuing along said line S 51°02'07" W 383.31 feet for a total distance of 445.17 feet to a 5/8 inch dia. rebar capped: KED 4975-S located on the northerly Right-of-Way line of the Burlington Northern Railroad line which measures 100.00 feet from the centerline thereof; thence, S 58°59'17" E 127.21 feet to the point of beginning.

The above described tract of land contains 1.085 acres, more or less, including a 40 foot long x 50 foot wide septic easement to be utilized by Parcel "B", all as shown hereon.
