Beginning at a 5/8 inch rebar capped 7318-S marking the Northwest corner of the NE 1/4 of the NW 1/4 of Section 1; thence along the North line of said Section S 89°54'16" E, 220.10 feet to a rebar capped 9958-S; thence S 1°48'05" W, 254.11 feet along the West Right of Way of Autumn Road, a 60.00 foot wide county road, to a rebar capped 9958-S; thence N 89°54'16" W, 211.00 feet to a rebar capped 9958-S; thence along the west line of the NE 1/4 of the NW 1/4, N 0°15'59" W, 254.01 feet to the TRUE POINT OF BEGINNING; encompassing an area of 1.25 acres.

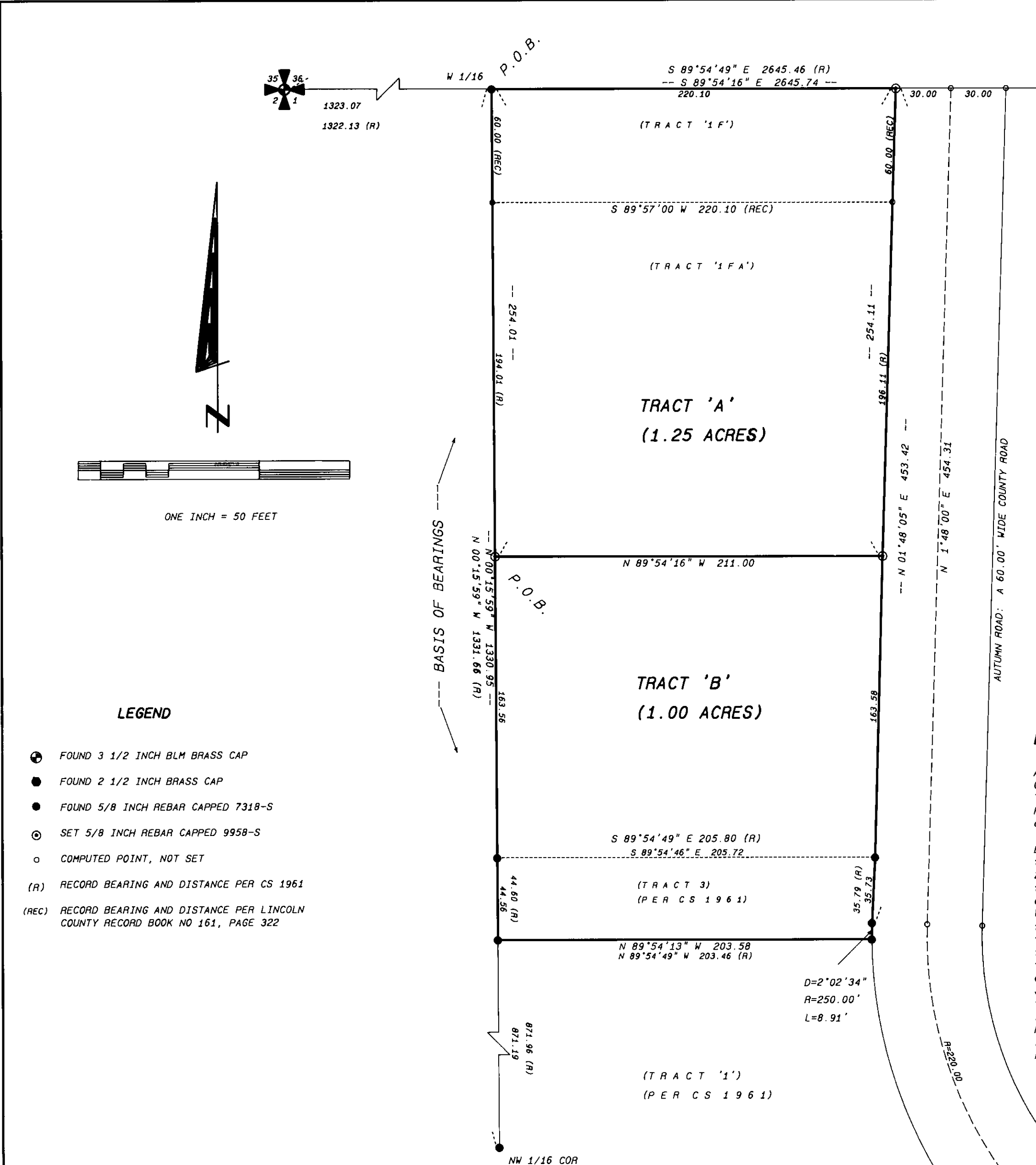

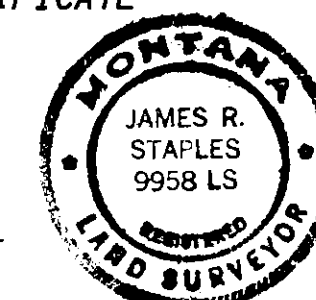
