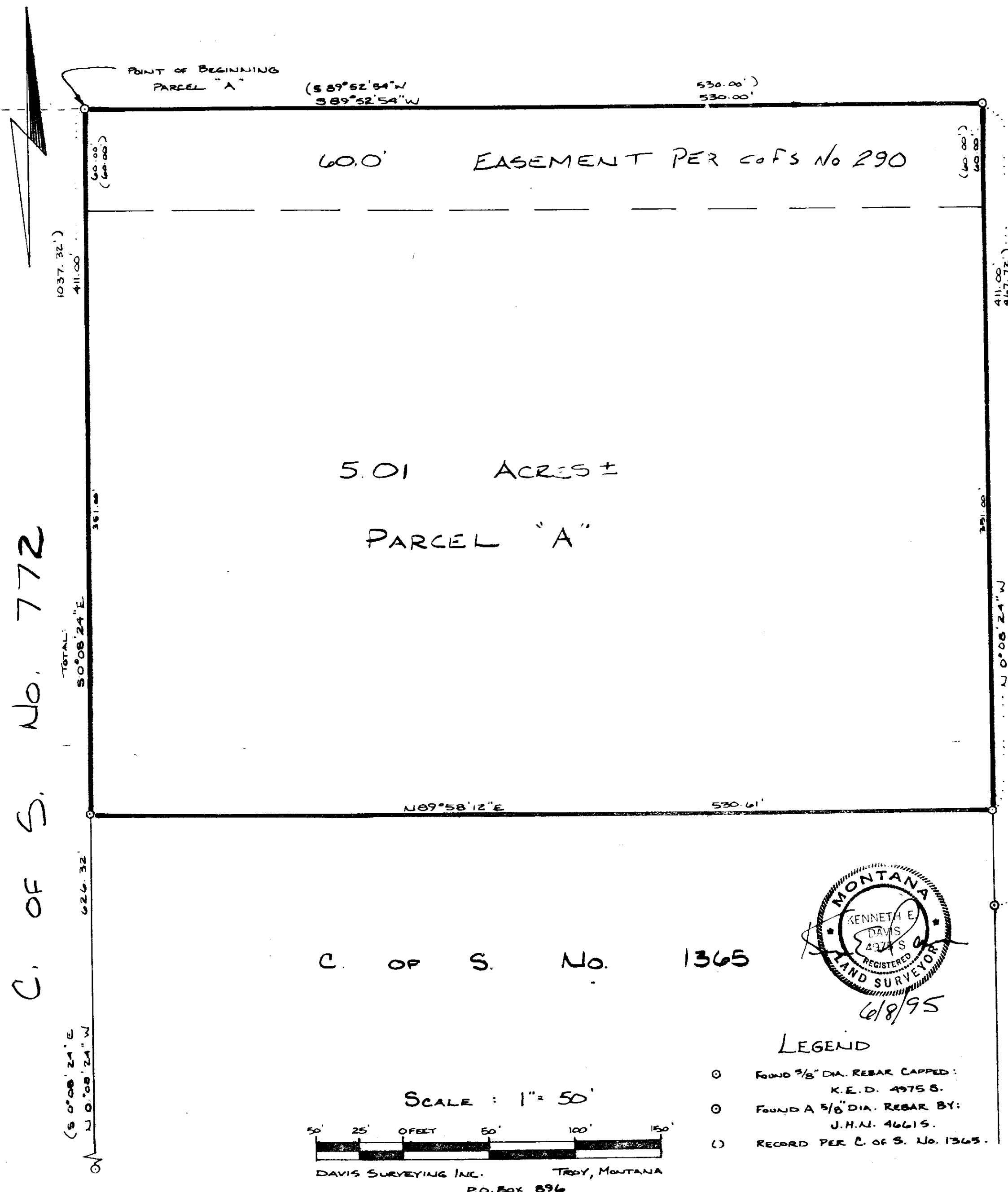

RETRACEMENT

C. OF S. No 1307



DESCRIPTION PARCEL "A"

A rectangular tract of land near Troy in Lincoln County, Montana, being a part of C. of S. No. 1365, lying within the NW 1/4 SE 1/4 of Section 28, Twp. 31 N., R. 33 W., P.M.M., and more particularly described as follows:

Beginning at a 5/8 inch rebar capped: JHN 4661 S marking the Northwest corner of said C. of S. No. 1365 and the Northeast corner of C. of S. No. 772 in said Section 28; thence, along the Westerly line of said C. of S. No. 1365 and the Easterly line of said C. of S. No. 772 S 0°08'24" E 411.00 feet to a found 5/8 inch rebar capped: KED 4975 S; thence, leaving said lines, N 89°58'12" E 530.61 feet to a found 5/8 inch rebar capped: KED 4975 S on the Easterly line of said C. of S. No. 1365 and the Westerly line of C. of S. No. 409; thence, along said lines N 0°08'24" W 411.00 feet to a 5/8 inch rebar capped: JHN 4661 S marking the Northeast corner of said C. of S. No. 1365; thence, leaving said lines along the North line of said C. of S. No. 1365, S 89°52'54" W 530.00 feet to the point of beginning.

The Aforescribed Parcel "A" contains 5.01 acres, more or less, excepting therefrom an Easement 60.00 feet in width for Utilities and access per C. of S. No. 290.

PURPOSE OF SURVEY

The purpose of this survey is to retrace the exterior boundaries of an existing tract of record, and no division of land is hereby created; therefore, this survey is exempt from review, being completed pursuant to Section 76-3-404, M.C.A.
