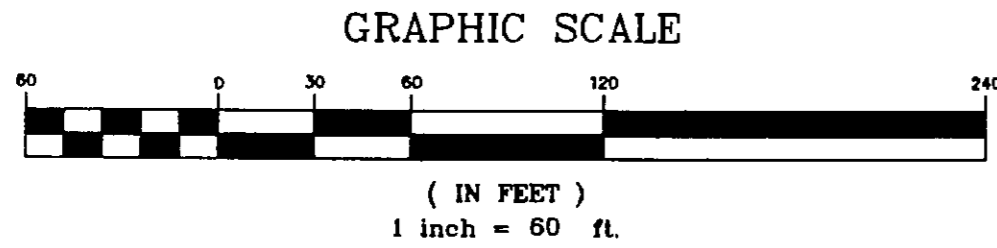

PURPOSE OF SURVEY

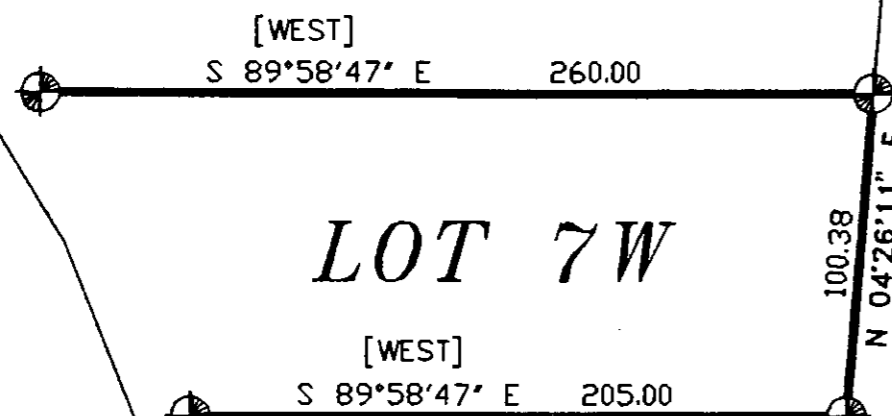

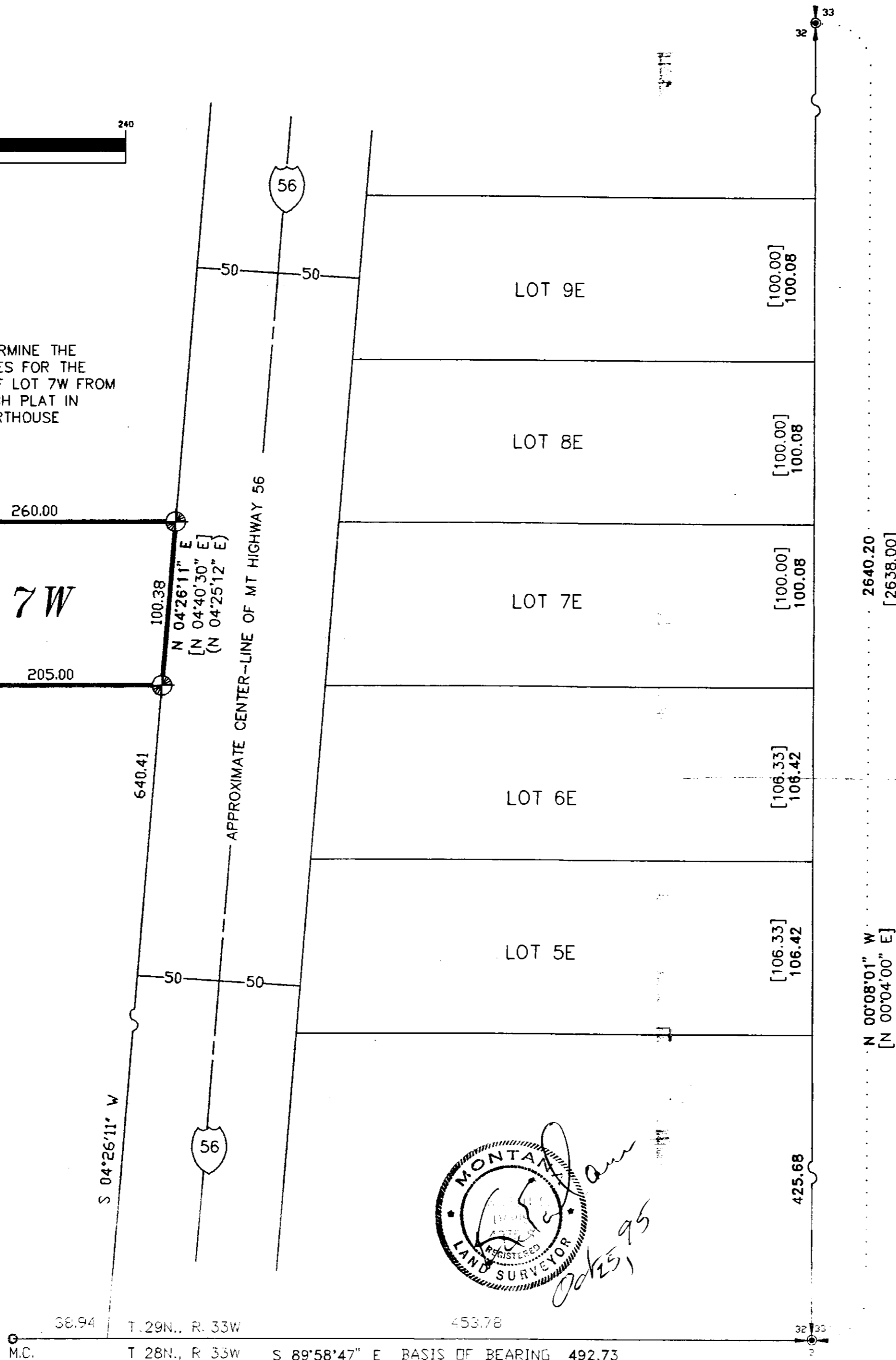
