

Putnam, Reg. #4375S. 1993, C.O.S. 2056, retraces portion of east boundry sec. 29 by Dawn Marquardt, Reg. #7328S.

### METHOD OF SURVEY

Control was accomplished using survey grade Global Positioning System receivers, and a constrained Least Squares Adjustment, based on N.G.S. first order control station "Airp" and 2nd order horizontal control station "Eureka". Secondary traverse done with Total Station — EDM.

### BASIS OF BEARING

Global Positioning System ties to N.G.S. control stations "Airp" and "Eureka" N.A.D. 83/International Feet.
