

KEIM/KRUEGER SUBDIVISION - TRACT A

A tract of land in Lincoln County, Montana, being a part of Lot 1 of Keim/Krueger Subdivision P.F. Plat No. 5296, lying within Section 14, Twp. 37 N, R. 28 W, P.M.M., containing 3.222 acres, more or less, and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped: KED 4975-S which bears N 30'34'34" E 1257.63 feet from a 3 1/4 inch dio. BLM brass cap marking the West 1/4 Corner of Section 14, Twp. 37 N, R. 28 W. P.M.M.; thence, from said point of beginning N 00'20'51" E 436.61 feet along the west line of Lot 1 of Keim/Krueger Subdivision to a 5/8 inch dia. rebar capped: KED 4975-S located on the south-easterly Right-of-Way line of a 60.00 foot wide public roadway known as West Kootenai River Road, said rebar measured 30.00 feet from the centerline thereof; thence. continuing along said westerly lot line N 00°20'51" E 41.46 feet to a computed point on the approximate centerline of said public roadway and the northwest lot corner of said Lot 1 of Keim/Krueger Subdivision; thence, N 46'41'47" E 235.61 feet along said centerline to a computed point; thence, S 10°16'13' E 34.91 feet to a 5/8 inch dia. rebar capped: KED 4975—S located on the southeasterly Right-of-Way line of a 60.00 foot wide public raadway known as West Kootengi River Road; thence, continuing along said line S 10?16'13" E 661.64 feet to a 5/8 inch dia. rebar capped: KED 4975-S lacated on the south line of said Lot 1; thence, N 81°09'06' W 302.34 feet along said south line to the point of beginning.

The aforedescribed tract of land (Tract A) contains 3.222 acres, more or less, and is subject to a 30.00 foot strip of land lying parallel with and adjacent to the westerly line thereof. Said strip is the southeasterly portion of West Kootenai River Road, as shown hereon.


