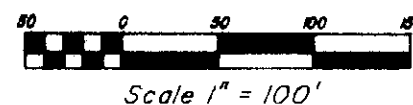

Parcel A

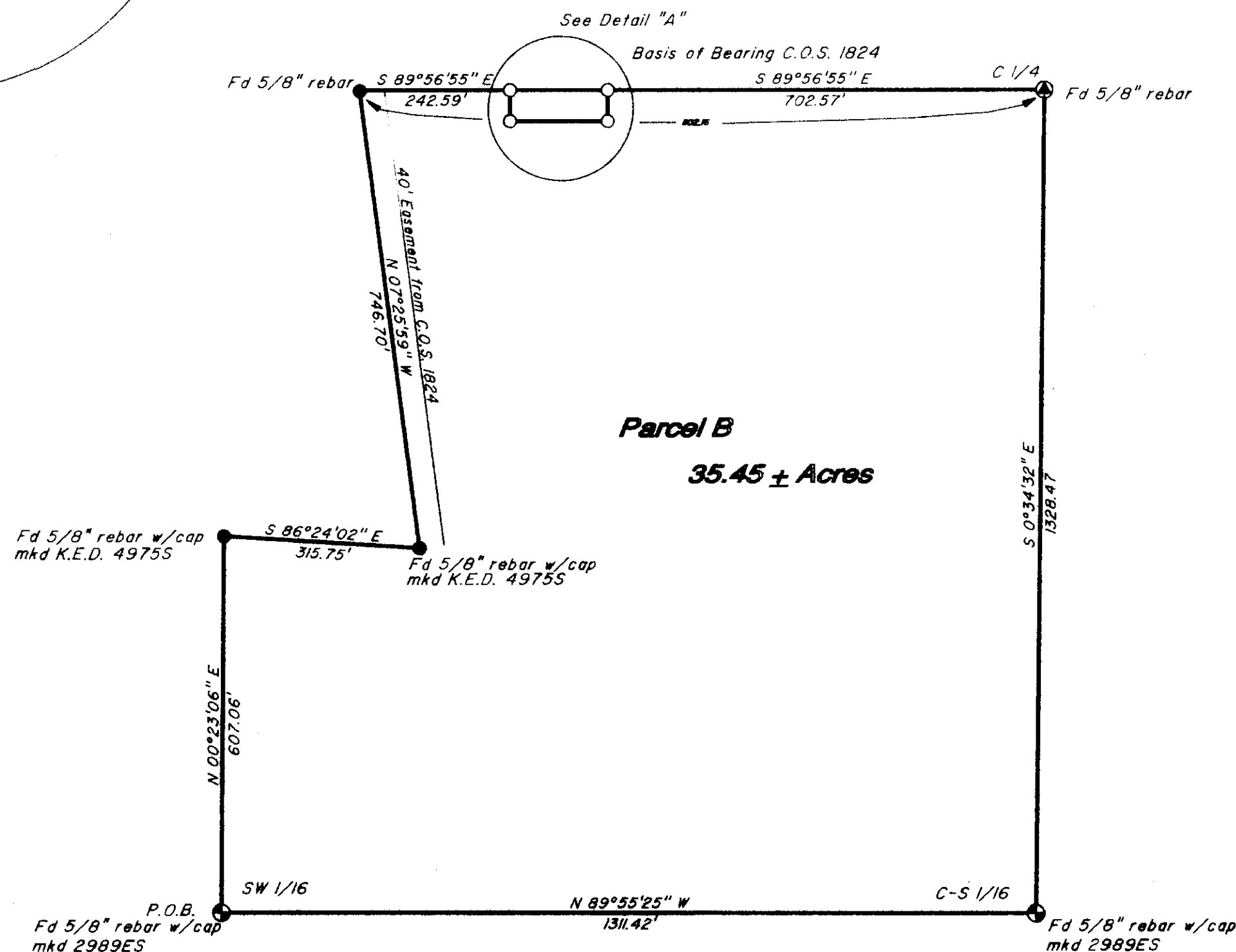
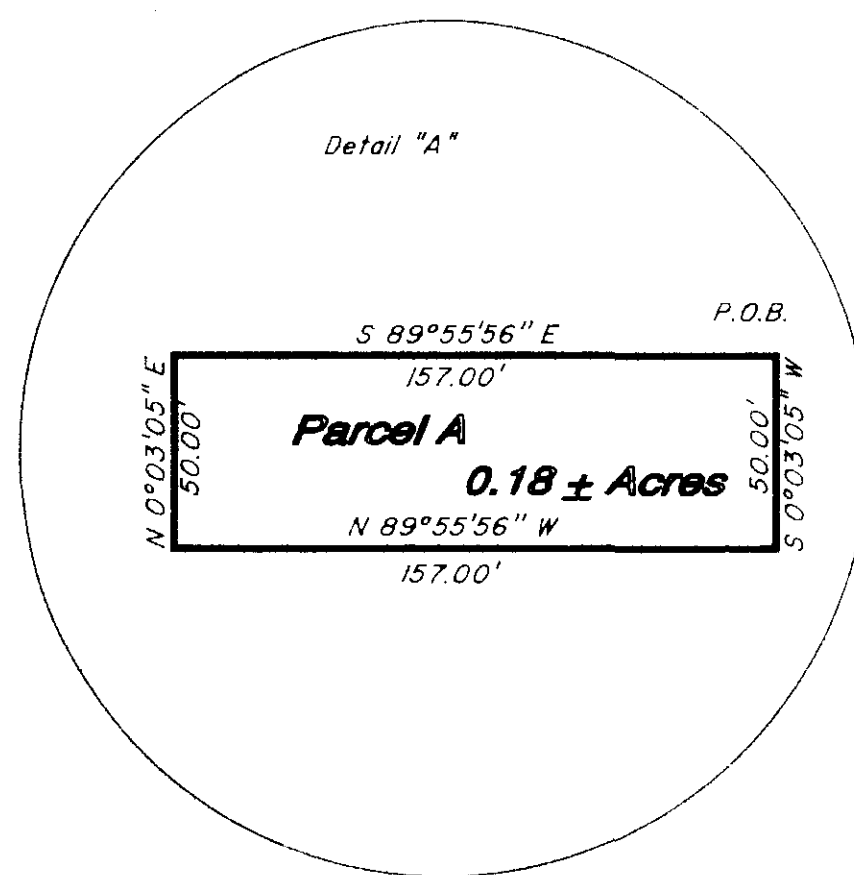

Parcel B

A tract of land situated, lying and being in Section 11, Township 37 North, Range 28 West, Principal Meridian, Lincoln County, Montana, and more particularly described as follows:
