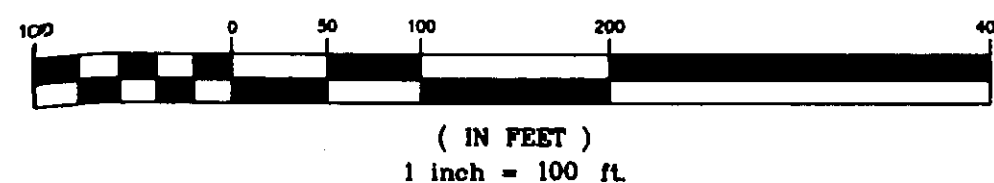

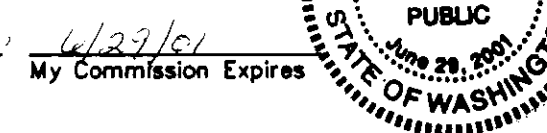

DESCRIPTION OF HARDING BOUNDARY ADJUSTMENT - PARCEL "A"

A tract of land near Yook, in Lincoln County, Montana, being a
part of HES 1179 and HES 273, located in Unsurveyed Section 36, Twp 36N.,
R 32 W., P.M.M., and more particularly described as follows:

Beginning at a found original stone, being Corner No. 1 of HES 1179
and Corner No. 1 of HES 273; thence, from said point of beginning along
the easterly line of Lot 2 of Harding Ranches (P.F. Plat No. 5254),
N 19°55'24" E 260.00 feet to a set 5/8 inch dia. rebar capped: KED
4975-S; thence, S 10°02'36" E 89.92 feet to a computed point; thence,
S 20°37'57" E 129.00 feet to a set 5/8 inch dia. rebar capped: KED
4975-S; thence, S 72°10'28" W 157.35 feet to a set 5/8 inch dia. rebar
capped: KED 4975-S, lying on the easterly line of said Lot 2 of Harding
Ranches; thence, continuing along the easterly boundary of Lot 2 of Harding
Ranches N 00°15'31" E 13.00 feet to the point of beginning.
