


LEGAL DESCRIPTION

Commencing at the South One-Quarter corner of said Section 32, which is a found brass capped monument; thence, N. 67° 39' 07" West 641.77 feet to a set iron pin and the POINT OF BEGINNING of the tract herein described; thence, S. 64° 35' 02" W. 320.47 feet to a set iron pin; thence, N. 25° 24' 58" W. 679.63 feet to a set iron pin; thence, N. 64° 35' 02" E. 320.47 feet to a set iron pin; thence, S. 25° 24' 58" E. 679.63 feet to the POINT OF BEGINNING and containing 5.000 acres, more or less. Together with an 30 foot wide access easement over and across an existing driveway as shown hereon.
