

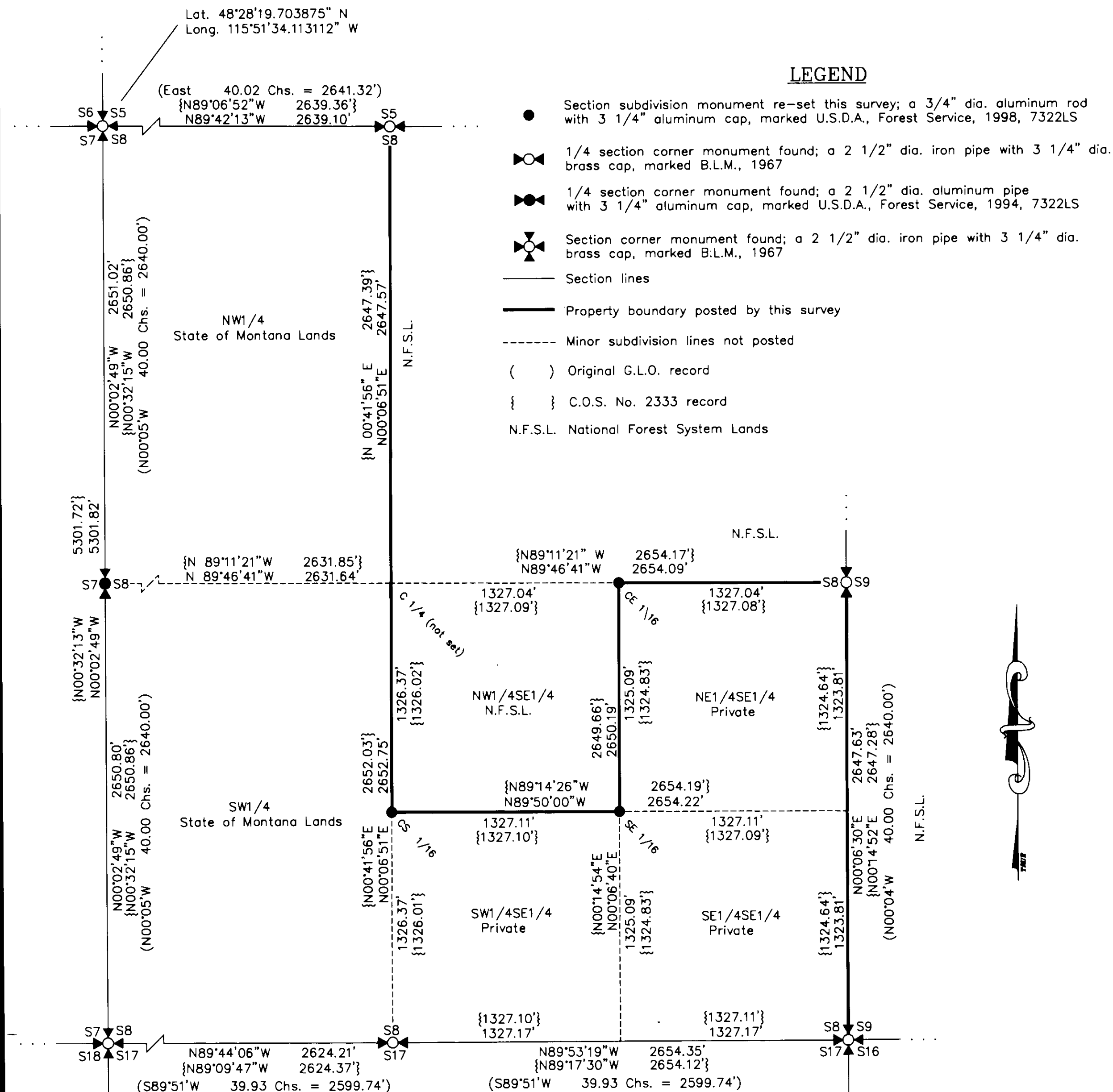

METHOD OF SURVEY

Control was accomplished using survey grade Global Positioning System receivers, and a constrained Least Squares Adjustment, based on N.G.S. first order control station "Freeman" and 1st order horizontal control station "Kay".

BASIS OF BEARING

Bearings are based on G.P.S. local control and a user defined Transverse Mercator coordinate system with a Central Meridian at latitude: 48°00'00" N and longitude: 115°53'59" W, scale factor 1.000119591417

SURVEYOR'S NOTES

This amended C.O.S. revises corner positions shown on C.O.S. No. 2333 due to readjustment of the control network. Original C.O.S. filed at Lincoln county on June 15, 1995

PURPOSE OF SURVEY

The purpose of this survey is to retrace and mark the boundaries of existing record parcels, distinguishing between National Forest System Lands and private lands, therefore no division of land is hereby created

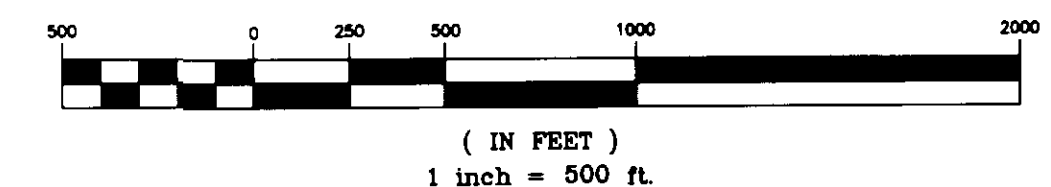
