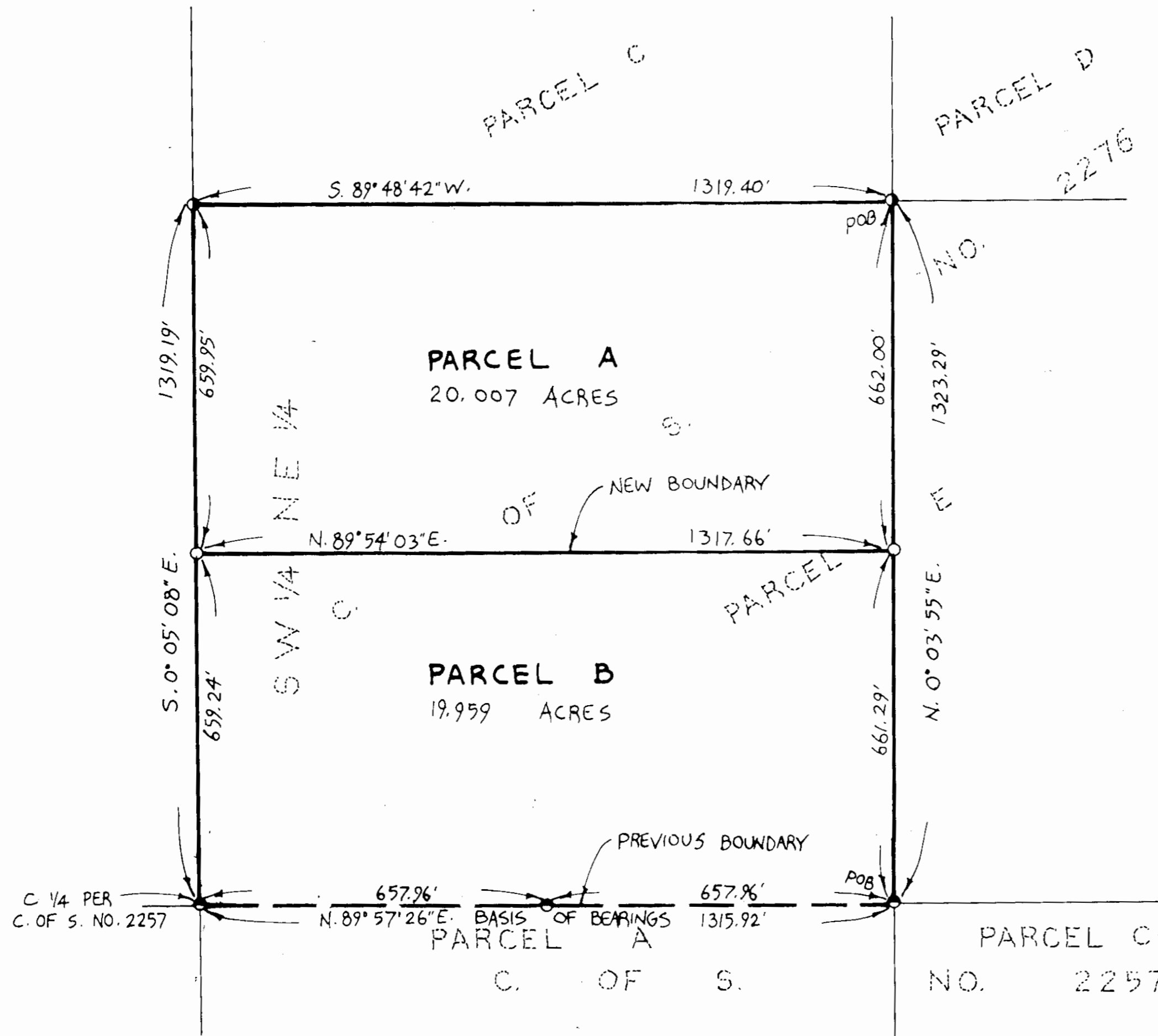

THAT PORTION OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4 OF SECTION 27, TOWNSHIP 37 NORTH, RANGE 28 WEST, P.M., M., LINCOLN COUNTY, MONTANA DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4; THENCE ALONG THE NORTH AND WEST LINES OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4 SOUTH 89°48'42" WEST 1319.40 FEET AND SOUTH 00°05'08" EAST 659.95 FEET; THENCE NORTH 89°54'03" EAST 1317.66 FEET TO THE EAST LINE OF THE SOUTHWEST 1/4 OF THE NORTHEAST 1/4; THENCE ALONG THE EAST LINE NORTH 00°03'55" EAST 662.00 FEET TO THE POINT OF BEGINNING CONTAINING 20.007 ACRES OF LAND ALL AS SHOWN HEREON.

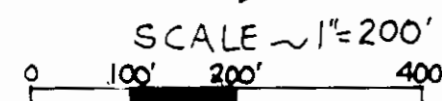
