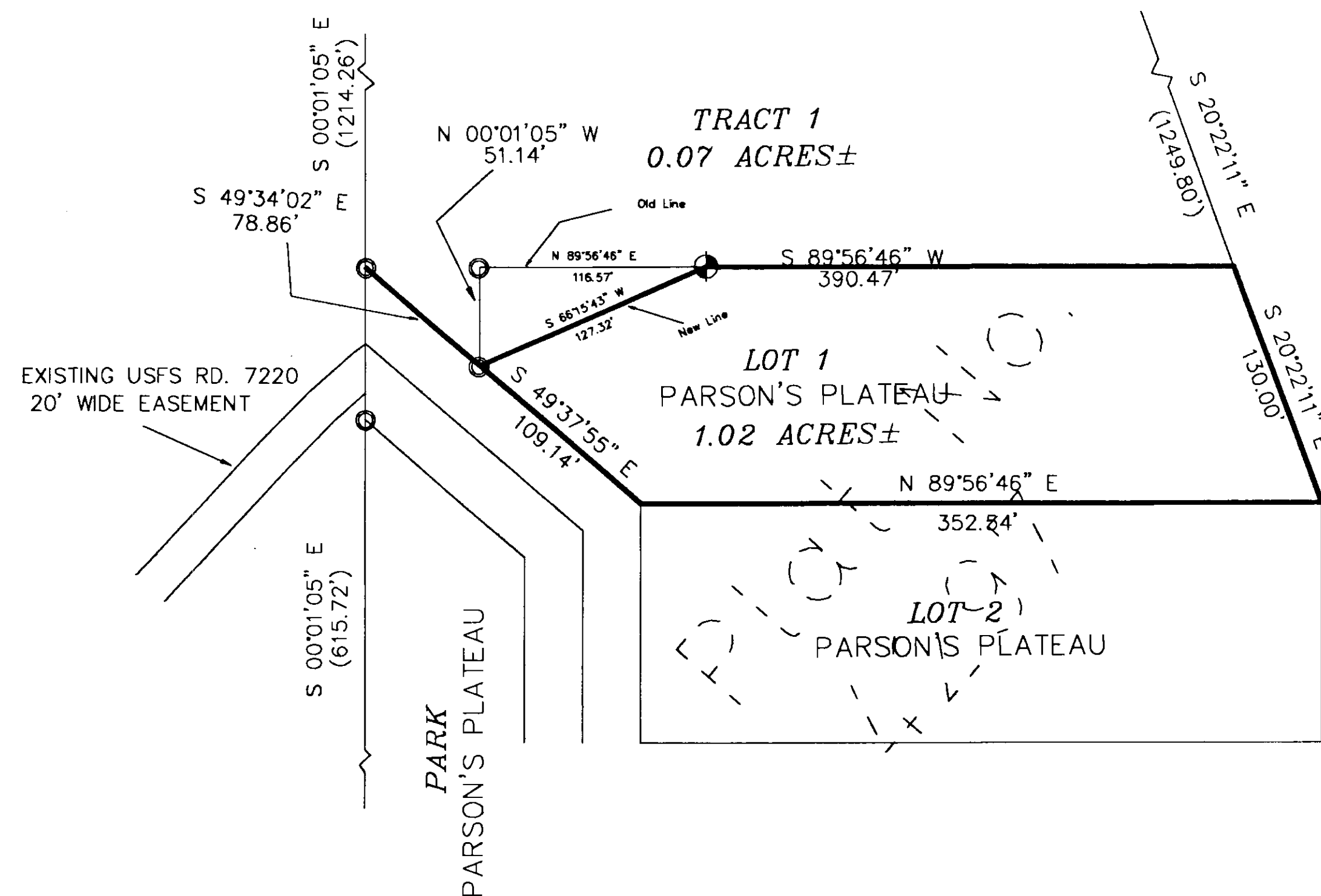


# CERTIFICATE OF SURVEY BOUNDARY ADJUSTMENT AMMENDED LOT 1

## DESCRIPTION OF TRACT 1

An irregular tract of land being a part of Lot 1 Parson's Plateau, Plat No. 4297 in the SW1/4 of Section 25, Twp.37N, R.28W, P.M.M. near Troy, Lincoln County, Montana, and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped: KED 4975-S and bearing S00°01'05"E 1214.29 feet from a 2 inch dia. Brass Cap stamped C of E and marking the West Quarter Corner of said section 25; thence S49°34'02"E 78.86 feet to a 5/8 inch dia. rebar capped: KED 4975-S being the true point of beginning; thence, N00°01'05"W 51.14 feet to a 5/8 inch dia. rebar capped: KED 4975-S; thence, N89°56'46"E 116.57 feet to a 5/8 inch dia. rebar capped: KED 4975-S; thence, S66°15'43"W 127.32 feet to the true point of beginning.

The aforescribed Tract 1 contains 0.07 Acres and is to become a part of the Remainder per the Plat of Parson's Plateau Plat No. 4297 and is subject to and together with all appurtenant easements of record.
