Commencing at a 5/8 inch rebar with a yellow plastic cap marked Larsen 3908S, located on the section line and the easterly line of Tract 1, as shown on Certificate of Survey No. 1714, being the N1/16th corner of said Section 13, lying on the section line and the TRUE POINT OF BEGINNING; thence N00°00'18"W, a distance of 68.19 feet to a 5/8 inch rebar with a yellow plastic cap marked Larsen 3908S and on the southerly line of a 60.00 foot road and utility easement, thence continuing along the section line bearing N00°00'18"W, a distance of 36.25 feet to an unmarked intersection point with the centerline of said road easement; thence along the centerline, a tangent bearing N55°52'27"W, a distance of 54.18 feet to an unmarked point and the point of curvature of a curve to the left having a central angle of 20°26'03" and a radius of 124.00 feet to an unmarked point and the point of tangency; thence along a tangent bearing N76°20'32"W, a distance of 59.13 feet to a point of curvature of a curve to the right, having a central angle of 34°39'27" and a radius of 314.00 feet to an unmarked point and the point of tangency; thence along a tangent bearing N39°45'45"W, a distance of 170.01 feet to an unmarked point; thence leaving the road centerline on a line bearing S48°08'44"W, a distance of 30.02 feet to a 5/8 inch rebar with a yellow plastic cap marked Larsen 3908S and on said road right-of-way limit; thence S24°29'36"W, a distance of 400.04 feet to a 5/8 inch rebar with a yellow plastic cap marked Hughes 7322LS; thence along the southerly line of said Tract 1, bearing S89°17'50"E, a distance of 600.00 feet to a 5/8 inch rebar with a yellow plastic cap marked Larsen 3908S, said N1/16th corner and the TRUE POINT OF BEGINNING and containing ±2.884 acres.

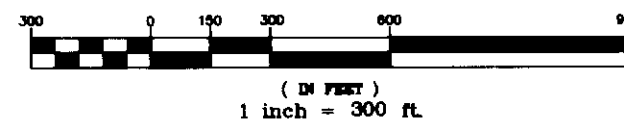

Commencing at a 5/8 inch rebar with a yellow plastic cap marked Larsen 3908S, located on the section line and the easterly line of Tract 1, as shown on Certificate of Survey No. 1714, being the N1/16th corner of said Section 13; thence along the southerly line of said Tract 1, bearing N89°17'50"W, a distance of 600.00 feet to a 5/8 inch rebar with a yellow plastic cap marked Hughes 7322LS and the TRUE POINT OF BEGINNING; thence N24°29'36"E, a distance of 400.04 feet to a 5/8 inch rebar with a yellow plastic cap marked Larsen 3908S lying on the southerly right-of-way limit of a 60.00 foot road and utility easement; thence on a line bearing N48°08'44"E, a distance of 30.02 feet to an unmarked point on the centerline of said road easement and the point of curvature; thence along a curve to the left having a central angle of 6°38'59" and a radius of 1194.00 feet to an unmarked point and the point of tangency; thence along a tangent bearing N48°15'05"W, a distance of 139.29 feet to an unmarked point and the point of curvature of a curve to the left having a central angle of 22°54'44" and a radius of 492.00 feet to an unmarked point and the point of tangency; thence along a tangent bearing N71°12'56"W, a distance of 148.94 feet to an unmarked point and the point of curvature of a curve to the right having a central angle of 15°27'59" and a radius of 326.00 feet to an unmarked point and the point of tangency; thence along a tangent bearing N55°42'42"W, a distance of 82.32 feet to an unmarked point on the centerline of said road and the intersection point; thence along a radial line bearing S11°35'20"W, a distance of 32.52 feet to a 5/8 inch rebar with a yellow plastic cap marked Hughes 7322LS; thence continuing along said line bearing S11°35'20"W, a distance of 219.34 feet to a 5/8 inch rebar with a yellow plastic cap marked Hughes 7322LS; thence S10°09'40"E, a distance of 195.36 feet to a 5/8 inch rebar with a yellow plastic cap marked Hughes 7322LS; thence S00°02'06"E, a distance of 358.01 feet to a point on the southerly line of Tract 1, a 5/8 inch rebar with a yellow plastic cap marked Hughes 7322LS; thence along the southerly line of said Tract 1, bearing S89°17'50"E, a distance of 489.58 feet to a 5/8 inch rebar with a yellow plastic cap marked Hughes 7322LS and the TRUE POINT OF BEGINNING and containing ±8.986 acres.
