

## **DESCRIPTION**

An irregular tract of land near Troy in Lincoln County, Montana lying in the NE 1/4 of Section 16, Twp. 33 N., R. 34 W., P.M.M. and containing 24.978 acres, more or less, and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped: JHN 4661—S and marking the C 1/4 corner of said Section 16, Twp. 33 N., R. 34 W., P.M.M.; thence, along the north—south centerline of said section N00°27′23″W 1324.71 feet to a 5/8 inch dia. rebar capped: JHN 4661—S marking the CN 1/16 corner of said section; thence, continuing along said north—south centerline N00°27'23"W 251.80 feet to a point on the centerline of an existing access road; thence, along said access road N79\*37'25"E 500.19 feet to a point; thence, 239.15 feet on the arc of a curve to the left having a radius of 189.77 feet and turning through a delta angle of 72°12'20"; thence, continuing along said access road NO3°42′40″E 161.66 feet to a 5/8 inch dia. rebar capped: JRS marking the NW-NE 1/64 corner of said section; thence, S00°30′43″E 662.62 feet to a 5/8 inch dia. rebar capped: KED 4975-S marking the C-W-NE 1/64 corner of said section; thence, S00'25'54"E 1325.53 feet to a 5/8 inch dia. rebar capped: KED 4975-S marking the C-W-E 1/64 of said section; thence, along the east—west centerline of said section S89'46'55"W 660.38 feet to the point of beginning.

The aforedescribed parcel contains 24.978 acres, more or less, and is subject to and together with all appurtenant easements of record.
