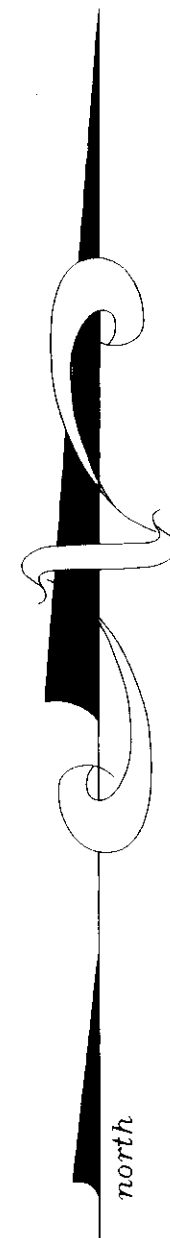
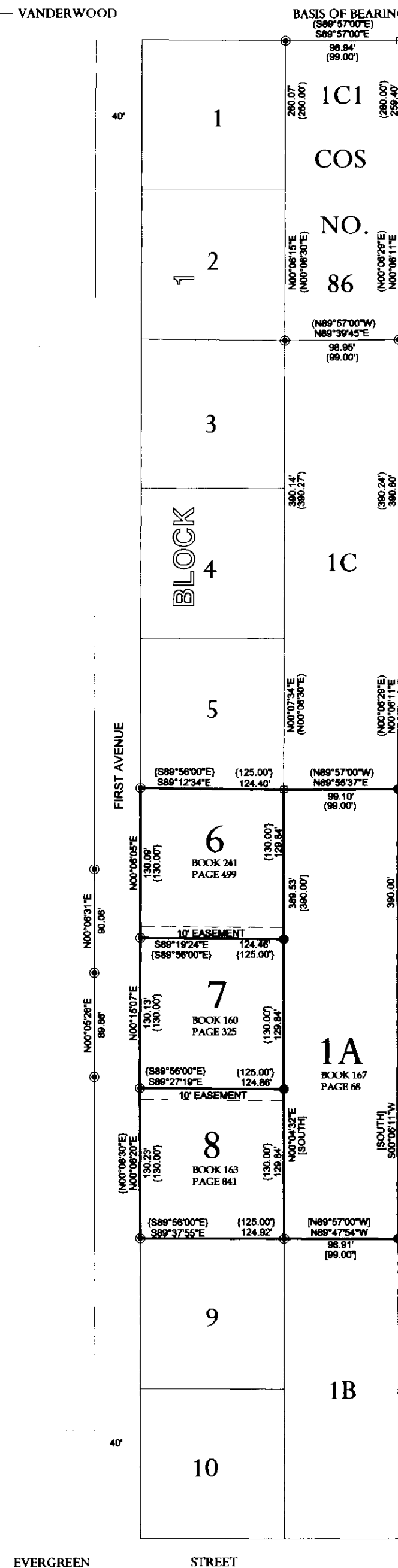

PLAT NO. 33

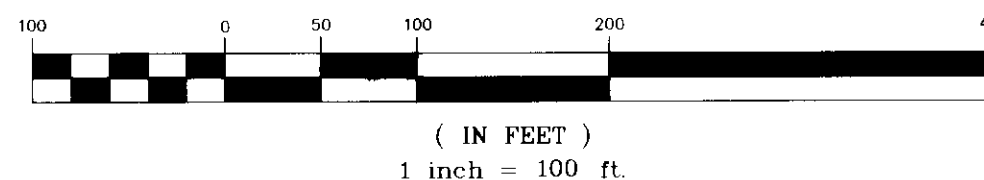


VANDERWOOD 40 SUBDIVISION

PURPOSE OF SURVEY

At the request of Mr. Pat Geer, owner of record, the purpose of this survey is the retracement of a record parcel of land, known as Lots 6, 7, and 8 of Block 1 of Mahoney's Suburban Addition to Libby and Tract "1-A" of The Vanderwood 40 Subdivision; the reestablishment of obliterated corners and flagging the property boundaries. Therefore no division of land is hereby created and is exempt from review as a subdivision.

METHOD OF SURVEY

A four second total station and data collector was used with closed traverse procedures to tie previously set controlling monuments.

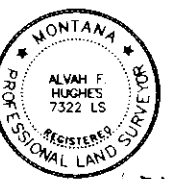
BASIS OF BEARING
