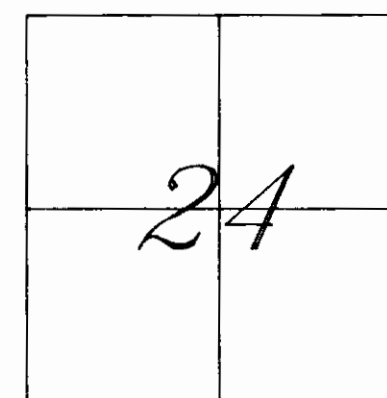

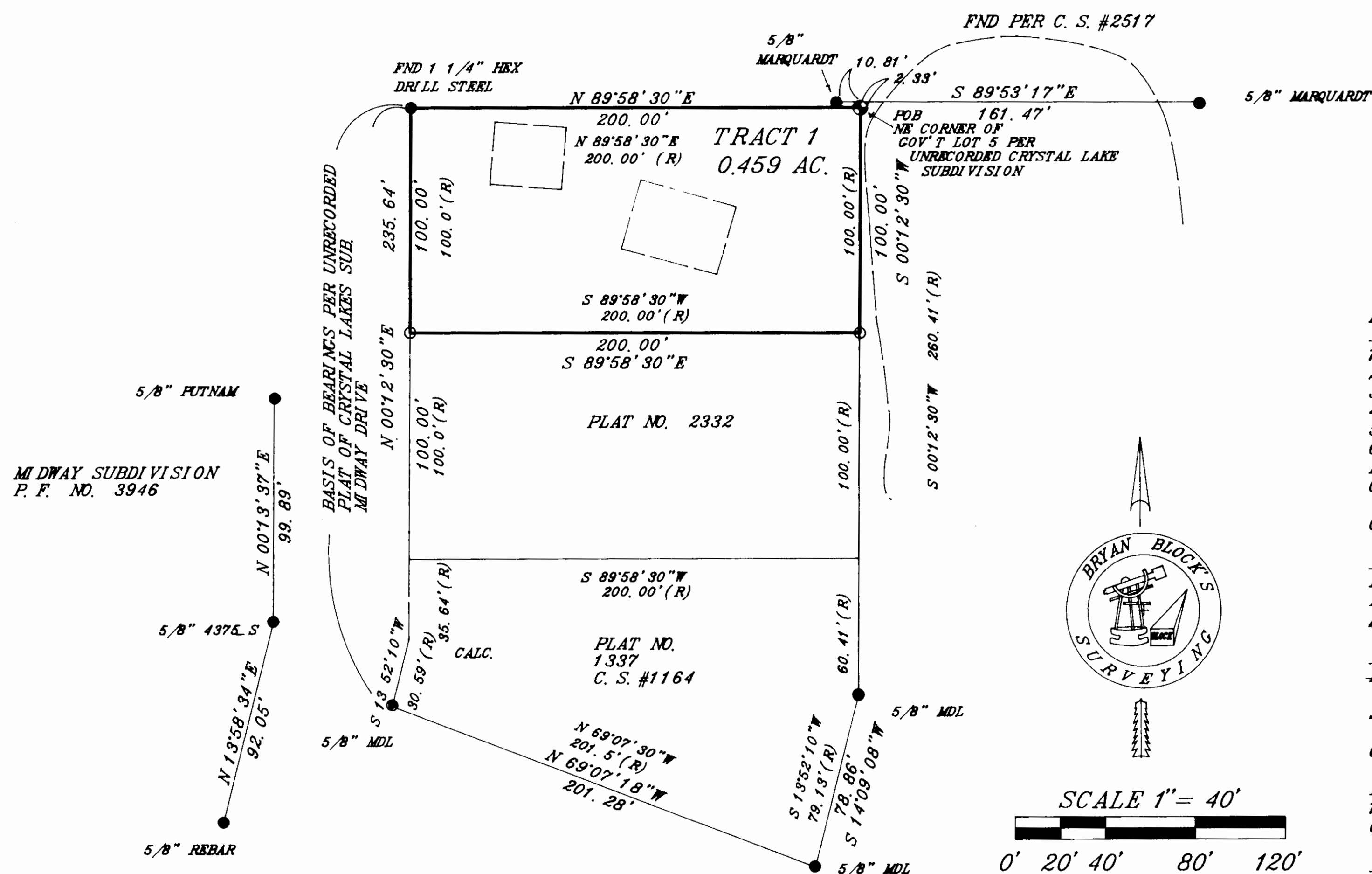
# CERTIFICATE OF SURVEY
