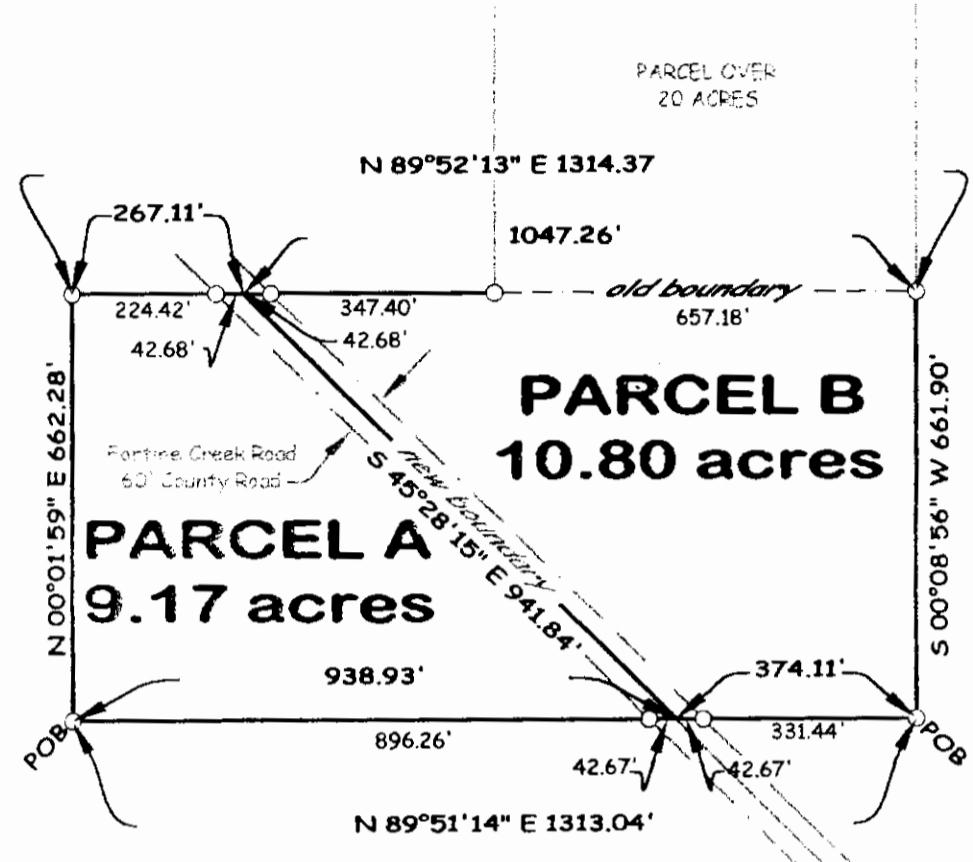
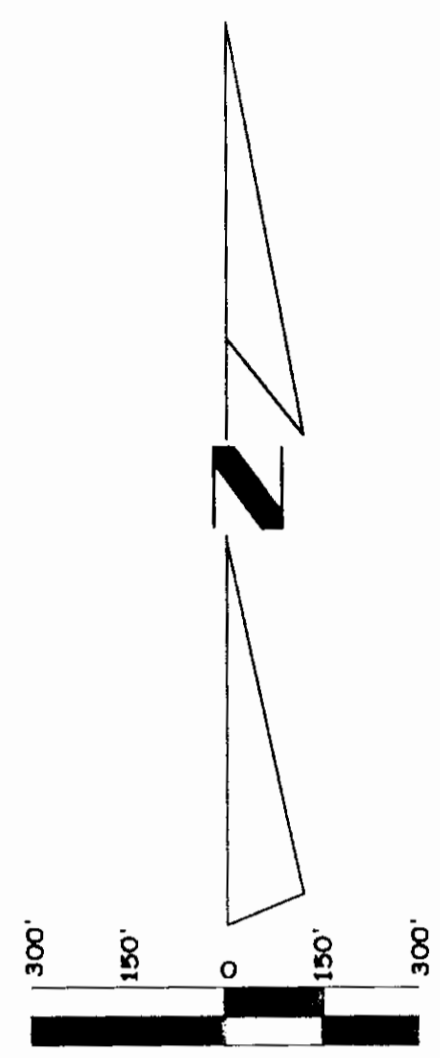

 thence along the West and North lines of the said North 1/2 of the Southeast 1/4 of the Southeast 1/4 of the Southeast 1/4 N00°01'59"E 662.28 and N89°52'13"E 267.11 feet to the centerline of Fortine Creek Road;
 thence along said centerline S45°28'15"E 941.84 feet to the South line of the North 1/2 of the Southeast 1/4 of the Southeast 1/4;
 thence along said South line S89°51'14"E 938.93 feet to the Point of Beginning.

 SUBJECT TO ALL existing easements and right-of-ways.

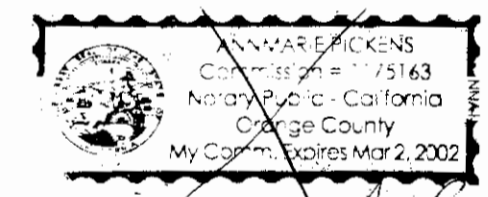
OWNERS CERTIFICATION

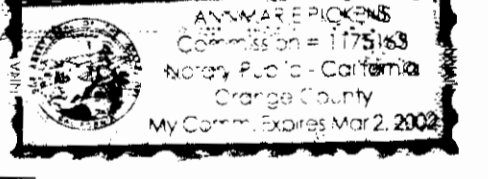

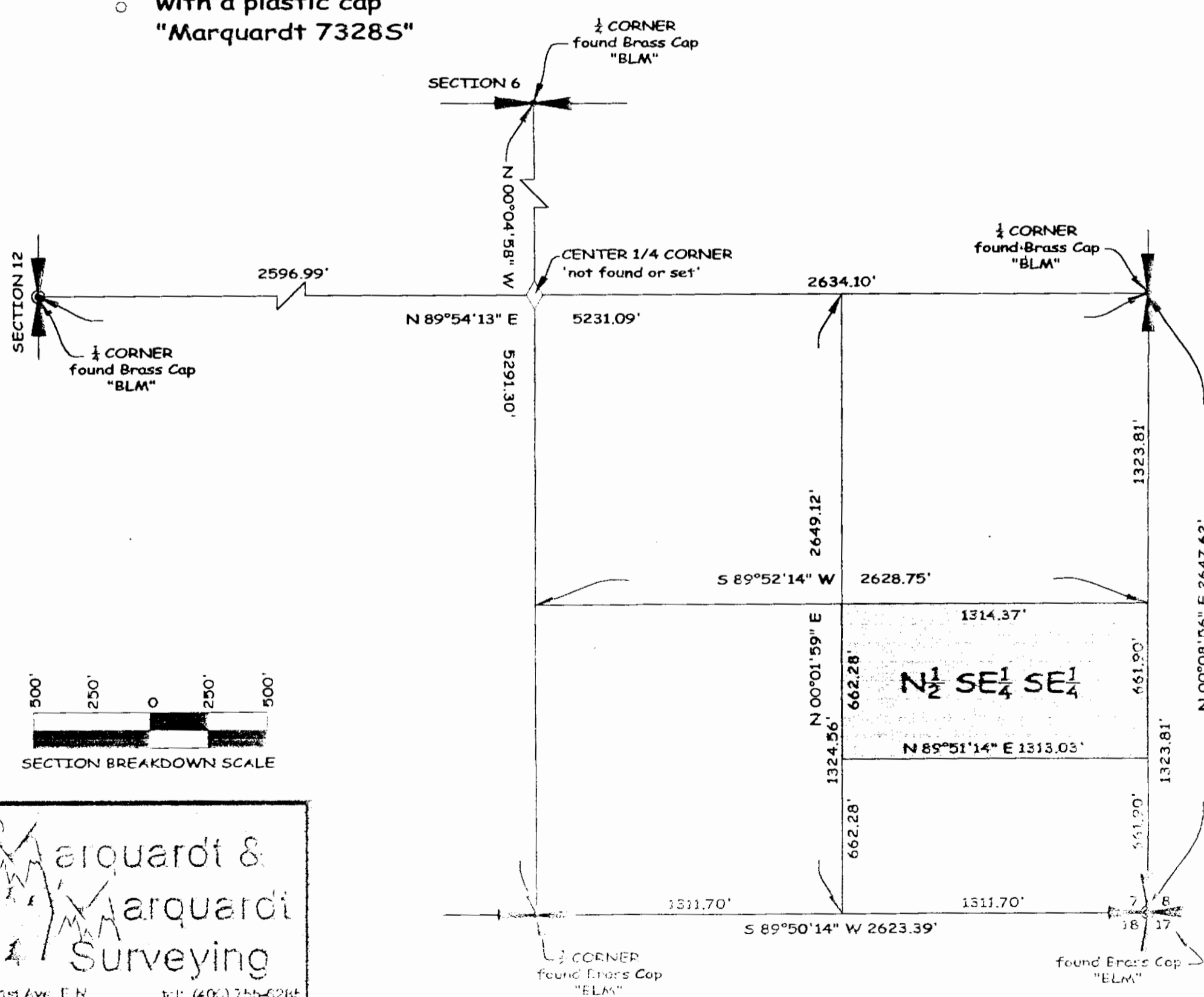
