

Beginning at a 2 1/2 inch dia. aluminum pipe with a 3 1/4 inch dia. aluminum cap marking the C-W 1/16 of Section 29, Twp. 36N., R27W., P.M.M.; thence, N00°16'13"E 107.17 feet along the north-south centerline of the NW 1/4 of Section 29, to a 5/8 inch dia. rebar capped KED 4975-S; thence, S75°16'46"E 419.88 feet to a 5/8 inch dia. rebar capped KED 4975-S located on the east-west centerline of said section 29; thence, S89°55'57"W 406.60 feet along the east-west center line of said section 29 to the point of beginning.
