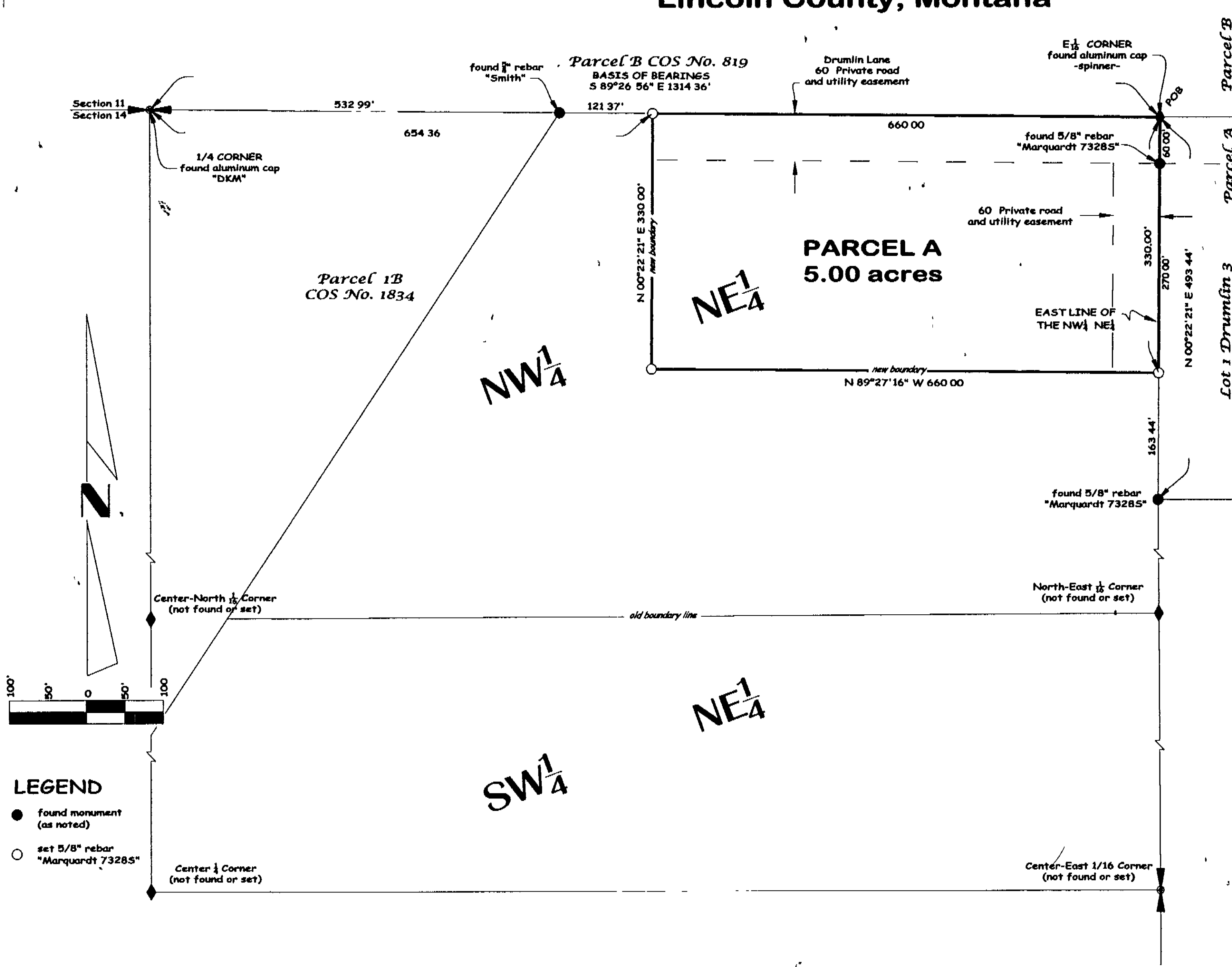

 Thence North 00°22'21" East 330.00 feet to the North line of the Northwest 1/4 of the Northeast 1/4,  
 Thence along the North line South 89°26'56" East 660.00 feet to the Point of Beginning containing 5.00 acres of land all as shown hereon.  
 Subject to easements of record  
 Subject to and together with a private road and utility easement as shown.
