

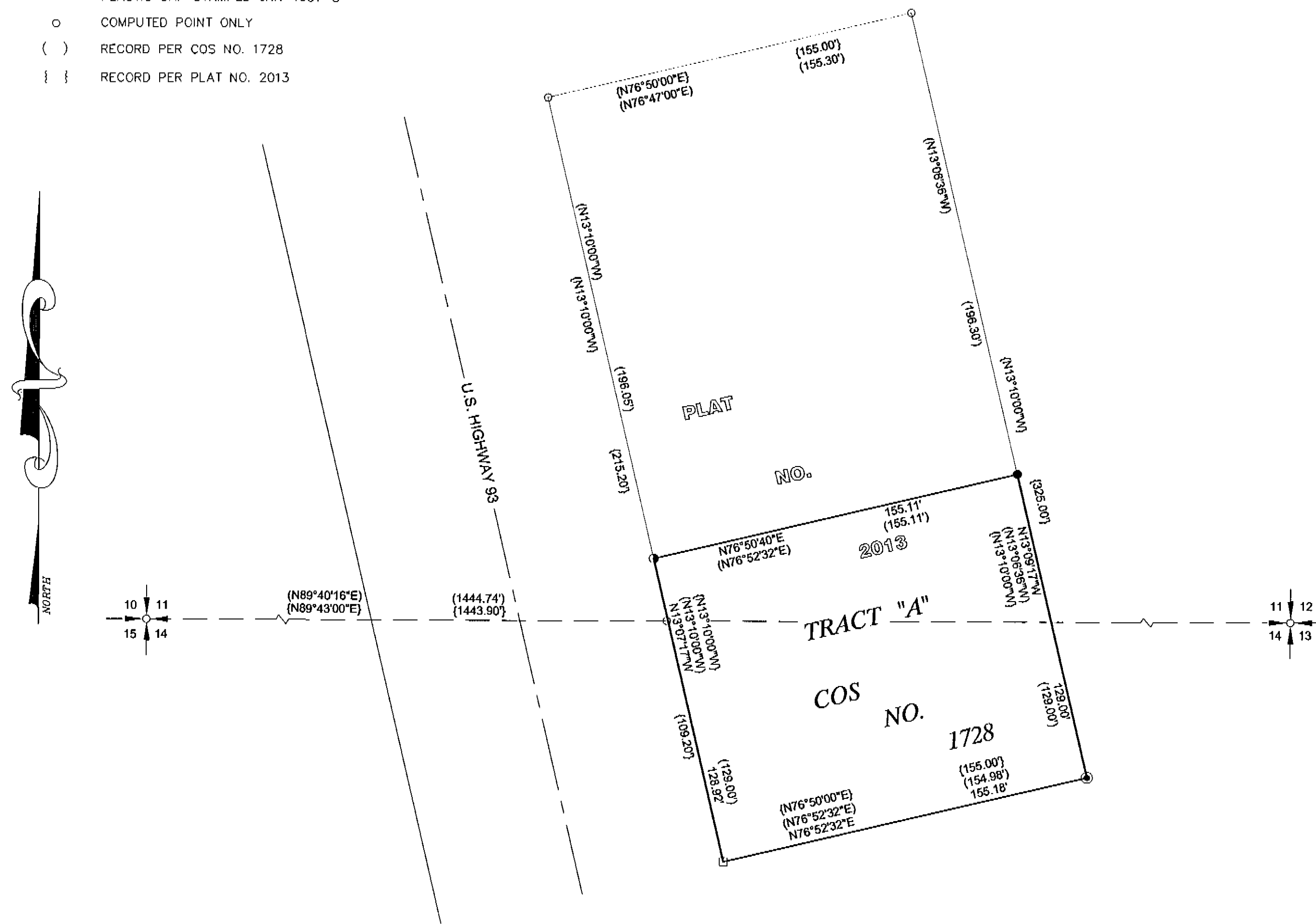

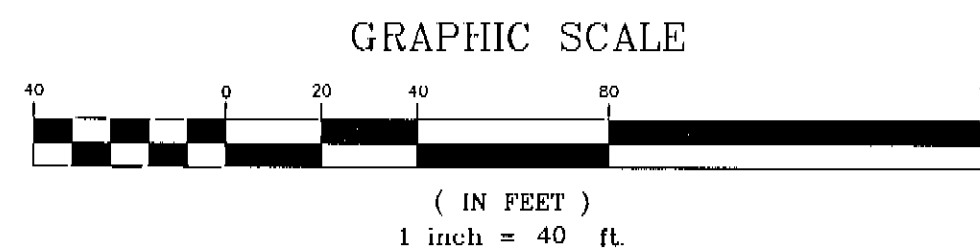

## PURPOSE OF SURVEY

The purpose of this survey is the retracement of a record parcel of land, Tract "A" of Certificate of Survey No. 1728; the re-establishment of an obliterated corner and marking property boundaries. Therefore no division of land is hereby created and is exempt from review as a subdivision.

## METHOD OF SURVEY

A four second Nikon total station and data collector was used with closed traverse procedures to tie previously set controlling monuments.

## BASIS OF BEARING

The basis of bearing for this survey is N76°52'32"E, as shown on COS No. 1728, between two found monuments.
