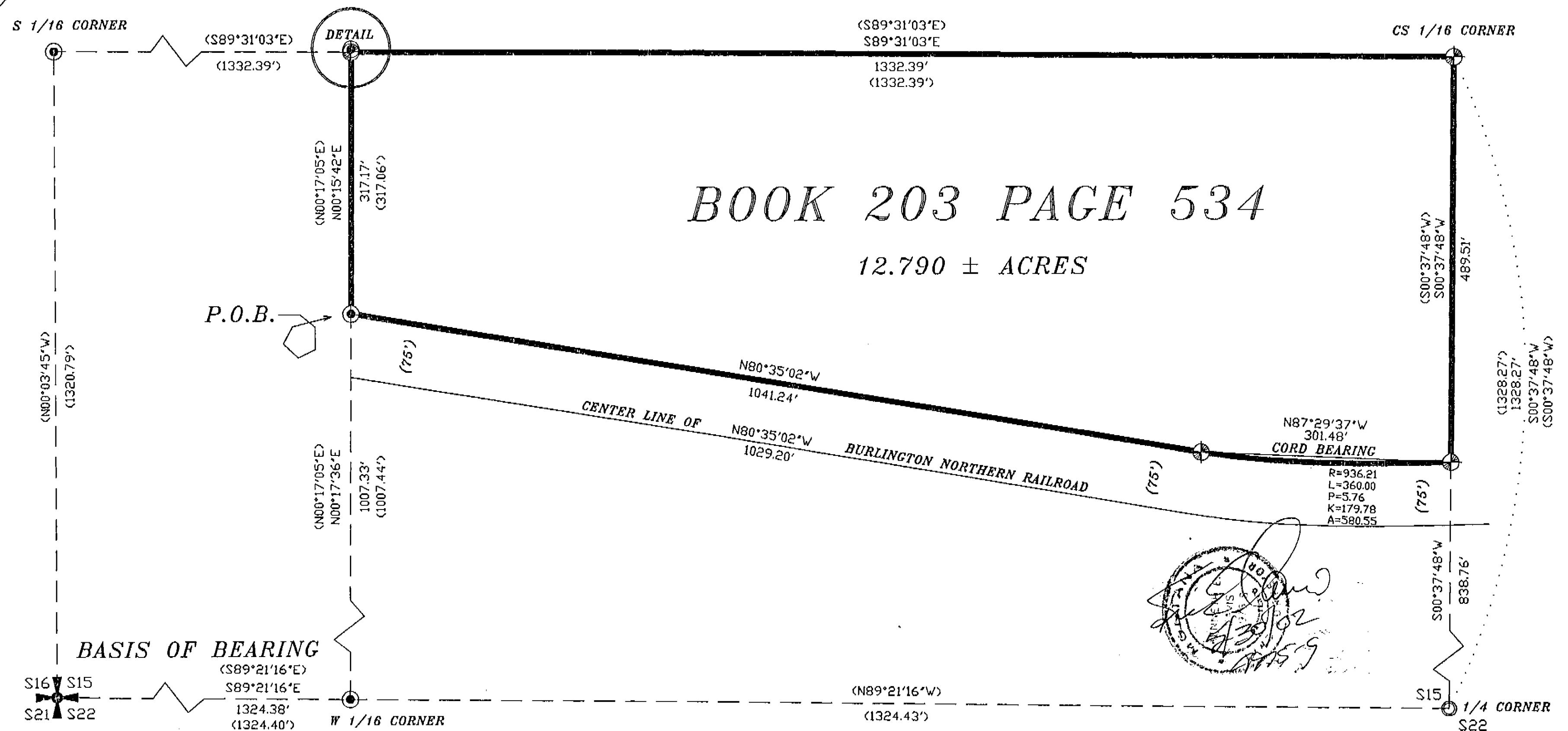
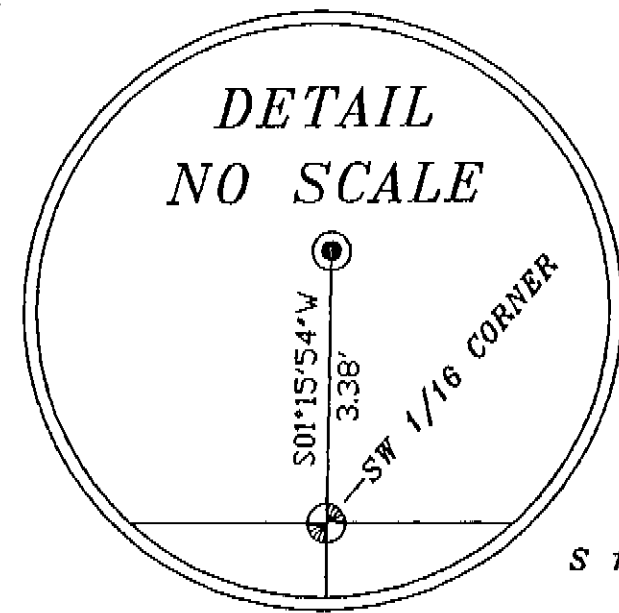

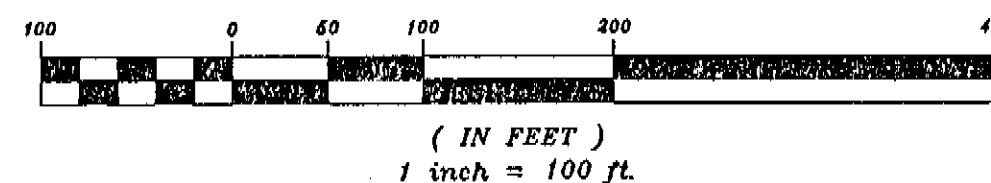

DESCRIPTION OF BOOK 203 PAGE 534

An irregular tract of land near Troy, in Lincoln County, Montana, being in the SE 1/4 of the SW 1/4 Section 15, Twp.31N.,R.33W., P.M.M., containing 12.790 acres more or less and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped: JHN 4661S, which bears N00°17'36"E 1007.33 feet from the W 1/16 corner of Section 15, Twp.31N.,R.33W., P.M.M.; thence, along the northsouth center line of the SW 1/4 of said Section 15, N00°15'42"E 317.17 feet to a 5/8 rebar capped: K.E.D. 4975-S, which marks the SW 1/16 corner of said Section 15; thence, along the eastwest centerline of the SW 1/4 of said Section 15, S89°31'03"E 1332.39 feet to a 5/8 inch dia. rebar capped: K.E.D. 4975-S, which marks the CS 1/16 corner of said Section 15; thence, along the northsouth centerline of said Section 15, S00°37'48"W 489.51 feet to a 5/8 inch dia. rebar capped: K.E.D. 4975-S; thence, along a spiral curve having a cord bearing of N87°29'37"W and being 301.48 feet in length to a 5/8 inch dia. rebar capped: K.E.D. 4975-S; thence, N80°35'02"W 1041.24 feet to the Point of Beginning.
