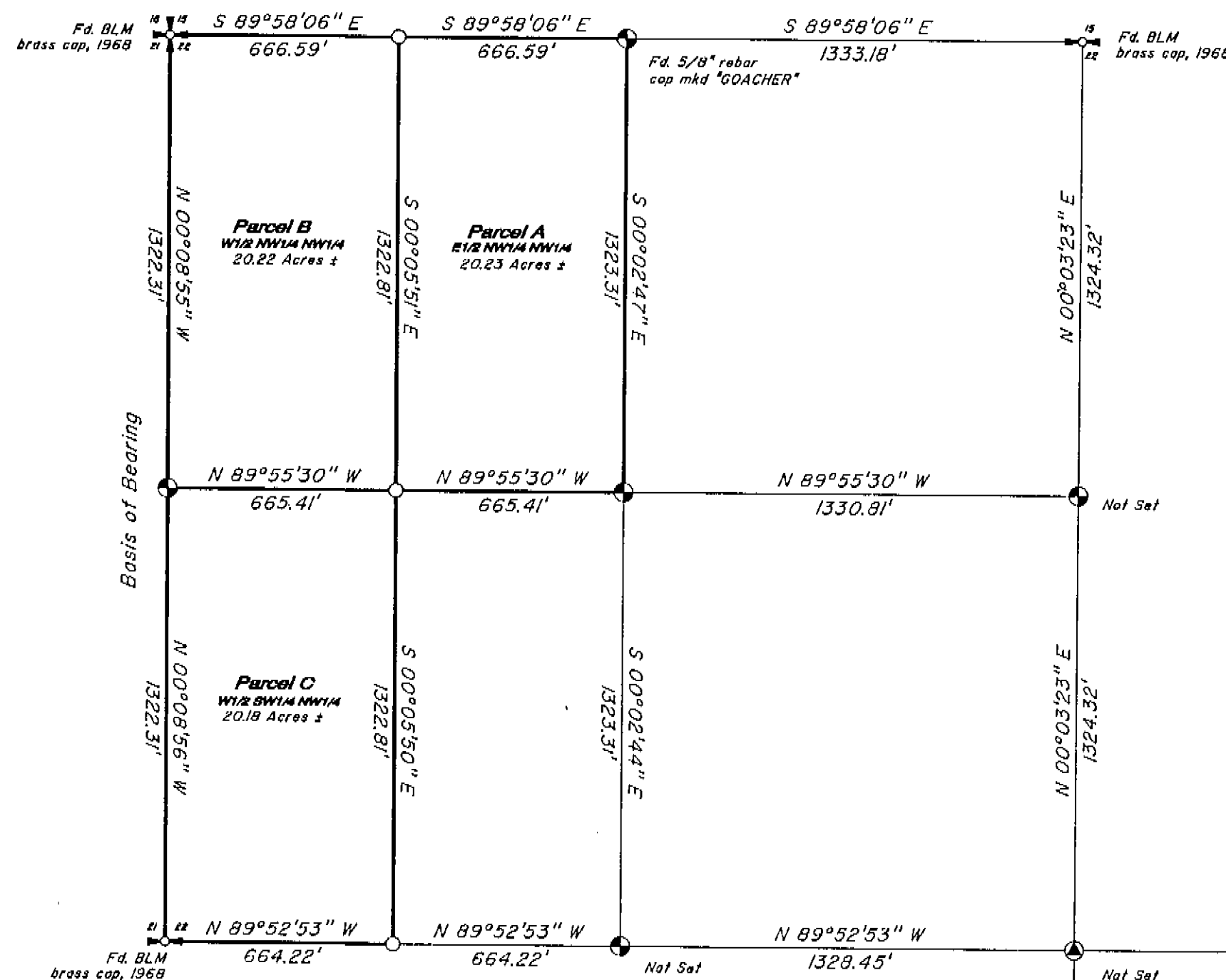

Legal Descriptions

Parcel A

A tract of land situated, lying, and being the east one-half of the northwest one-quarter of the northwest one-quarter of section 22, Township 34 North, Range 26 West. Containing 20.23 acres, more or less. Subject to all easements of record.

Parcel B

A tract of land situated, lying, and being the west one-half of the northwest one-quarter of the northwest one-quarter of section 22, Township 34 North, Range 26 West. Containing 20.22 acres, more or less. Subject to all easements of record.

Parcel C

A tract of land situated, lying, and being the west one-half of the southwest one-quarter of the northwest one-quarter of section 22, Township 34 North, Range 26 West. Containing 20.18 acres, more or less. Subject to all easements of record.

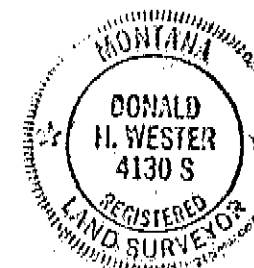
