

A total station and data collector was used with closed traverse procedures to tie previously set controlling monuments.

#### BASIS OF BEARING

in the centerline of Pinkham Creek;

The basis of bearing for this survey is N0°02'W, as shown on Plat No. 2015 between projected position of corner of sections 27, 28, 33, 34 and the S1/16 corner, a 3 1/4 inch diameter oluminum monument by Hughes 7322LS

#### LEGAL DESCRIPTION PARCEL "A"

A tract of land, southwest of Eureka, Montana, in Lincoln County, in NE1/4 SE1/4, Section 28, T.35N., R.27W., P.M.,MT., containing ±1.645 acres, and more particularly described as follows: Commencing at the S 1/16 corner, a 3 1/4 inch diameter aluminum monument marked Hughes 7322LS;

Thence N00°01'09"W, 236.23 feet to a 3/4 inch diameter rebar accepted as the southwesterly right of way limits for the Pinkham Creek Road, No. 856; Thence N44'30'35"W, 708.49 feet along said right of way limits to a 1 inch diameter bolt; Thence S24'36'17"E, 148.50 feet to a 3/4 inch diameter rebar being the True Point of Beginning Thence S66'52'00"W, 245.00 feet along the northwesterly line of Irregular Plat No. 2015 to a set 5/8 inch rebar marked Hughes 7322LS being a witness corner to Pinkham Creek;
