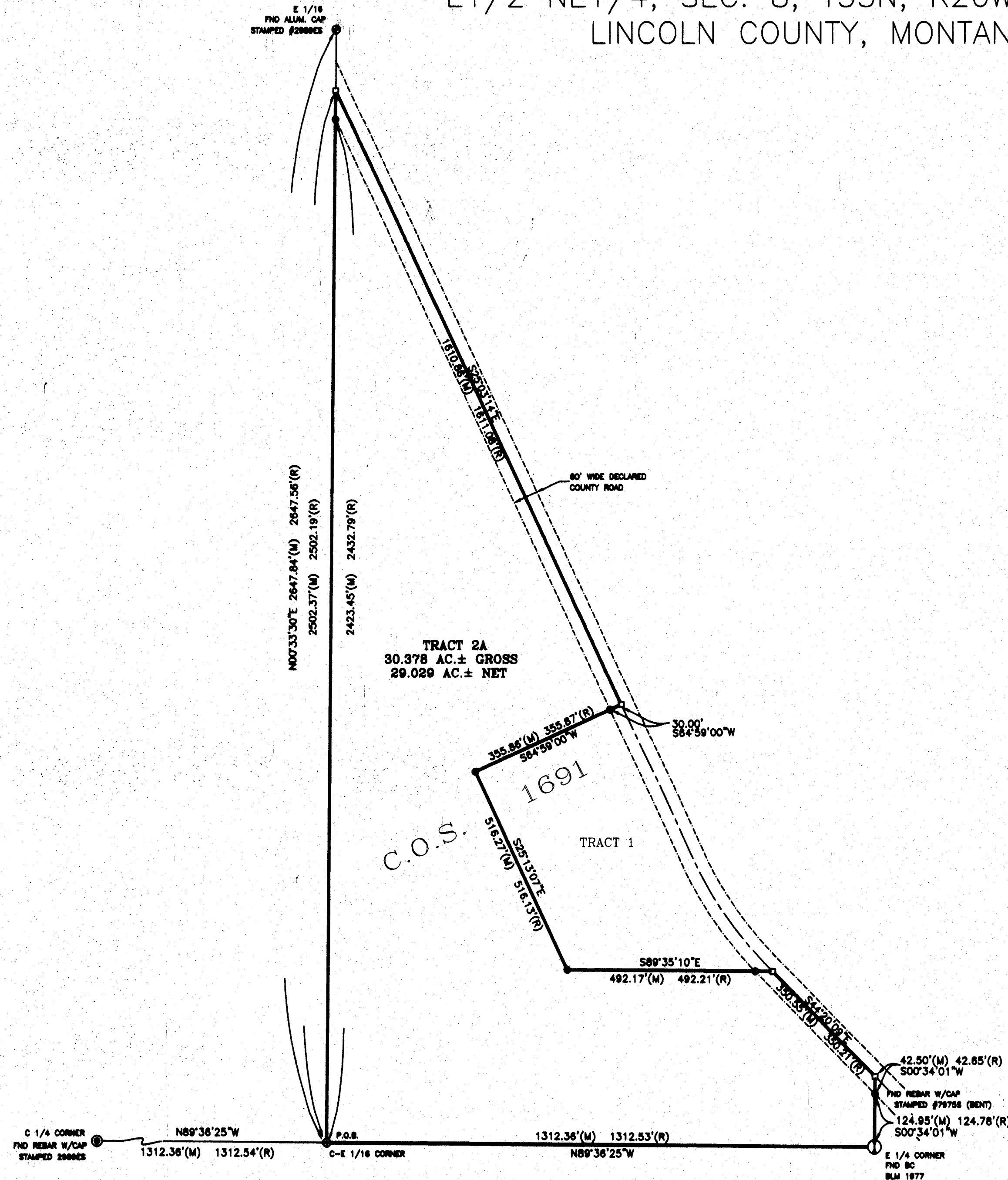

LINCOLN COUNTY, MONTANA

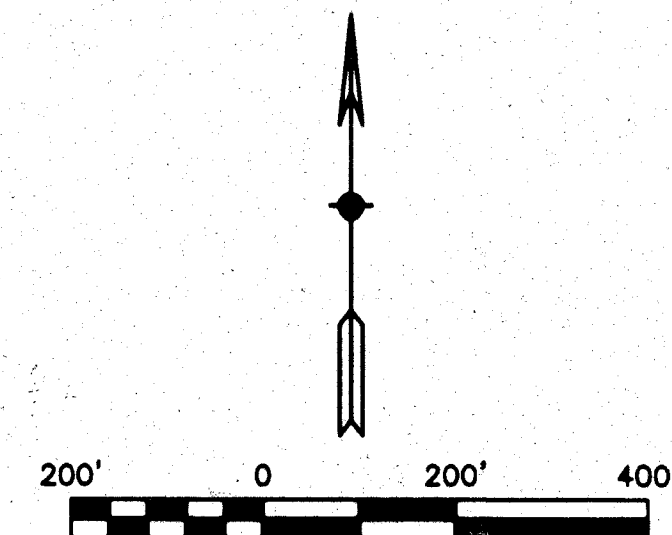


DESCRIPTION

That portion of the East one-half of the Northeast one-quarter (E1/2NE1/4) of Section Eight (8), Township Thirty-five North (T35N), Range Twenty-six West (R26W), Principal Meridian, Montana, Lincoln County, Montana, more particularly described as follows:

Beginning at the southwest corner of said East one-half of the Northeast one-quarter (E1/2NE1/4) of Section Eight (8); thence North00°33'30"East 2502.37 feet along the westerly boundary of said East one-half of the Northeast one-quarter (E1/2NE1/4) of Section Eight (8) to the centerline of a 60-foot wide declared county road; thence South25°03'14"East 1810.88 feet along said centerline; thence South64°59'00"West 385.86 feet; thence South25°13'07"East 516.27 feet; thence South89°35'10"East 492.17 feet to the centerline of said 60-foot wide declared county road; thence South44°20'09"East 350.55 feet along said centerline to the easterly boundary of said East one-half of the Northeast one-quarter (E1/2NE1/4) of Section Eight (8); thence South00°34'01"West 167.44 feet along said easterly boundary to the southeast corner of said East one-half of the Northeast one-quarter (E1/2NE1/4) of Section Eight (8); thence North89°36'25"West 1312.36 feet along the southerly boundary of said East one-half of the Northeast one-quarter (E1/2NE1/4) of Section Eight (8) to the point of beginning and containing 30.378 acres of land, gross measure, more or less. All as shown hereon.
