

Parcel A  
That portion of the Southeast 1/4 of the Northwest 1/4, Section 13, Township 33 North, Range 26 West, P.M., M., Lincoln County, Montana, described as follows:  
Beginning at the Northwest corner of the Southeast 1/4 of the Northwest 1/4:  
Thence along the North and East lines of the Southeast 1/4 of the Northwest 1/4 South 89°37'06" East 1312.36 feet and South 00°16'33" West 770.19 feet to a point on the centerline of Sunday Mountain Road, which point is on a 500.00 feet radius curve concave Southerly having a radial bearing of South 25°02'24" West;  
Thence along the centerline of Sunday Mountain Road, Westerly along the curve thru a central angle of 39°16'34" 342.75 feet;  
Thence South 75°45'50" West 300.80 feet to the beginning of a 1000.00 foot radius curve to the right;  
Thence Westerly along the curve thru a central angle of 40°20'42" 704.15 feet to the West line of the Southeast 1/4 of the Northwest 1/4;  
Thence, leaving the centerline of the road, along the West line of the Southeast 1/4 of the Northwest 1/4 North 00°16'08" East 749.93 feet to the Point of Beginning containing 23.86 acres of land all as shown hereon.  
Subject to and together with easements of record.  
Subject to road right of way as shown hereon.
