

## **DESCRIPTION OF PARCEL D-1**

A tract of land located near Libby in Lincoln County Montana, being a part of Parcel D per C.O.S. 1314, lying in the SW 1/4 of Section 10 Twp. 30 N., R. 31 W., P.M.M., and containing 7.11 acres more or less and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped M.D.L. 4232-S which marks the northwest corner of Highwood Park as shown on Plat No. 49; thence, N82°58'38"E 150.00 feet along the north line of said Highwood Park, to a 5/8 inch dia. rebar capped K.E.D. 4975-S set to mark the northeast corner of said Highwood Park; thence, N82°58'38"E 291.78 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N00°00'42"E 192.52 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N89°46'34"E 668.22 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, S00°02'30"W 20.00 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N89°46'34"E 108.87 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S located on the south right of way line of a 60.00 foot County roadway road petition no. 126; thence, N68°10'28"W 231.52 feet along said south right of way line, to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence on the arc of a curve to the left, a distance of 151.94 feet, turning through a delta angle of 12°59'35", and having a radius of 670.00 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, N81°10'03"W 78.90 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence on the arc of a curve to the right, a distance of 185.76 feet, turning through a delta angle of 10°20'00", and having a radius of 1030.00 feet, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N70°50'03"W 167.19 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, N70°40'00"W 118.29 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence on the arc of a curve to the left, a distance of 261.54 feet, turning through a delta angle of 40°30'01", and having a radius of 370.00 feet, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S68°49'59"W 142.63 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence leaving said south right of way line, S10°23'46"W 14.66 feet along the east line of Cabinet View per Plat No. 49, to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence continuing along said east line, S10°19'09"E 201.64 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence continuing along said east line, S06°51'51"E 240.09 feet to the point of beginning.

## DESCRIPTION OF REMAINDER

A tract of land located near Libby in Lincoln County Montana, being a part of Parcel D per C.O.S. 1314, lying in the SW 1/4 of Section 10 Twp. 30 N., R. 31 W., P.M.M., and containing 5.03 acres more or less and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped M.D.L. 4232-S which marks the most southerly corner of Parcel D per C.O.S. 1314; thence, N68°43'59"W 102.91 feet along the northeast line of the First Addition to Cabinet View plat No. 2425, to a 2 inch dia. pipe; thence, continuing along said northeast line, N42°24'01"W 39.44 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, continuing along said northeast line, N26°48'24"W 90.37 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, continuing along said northeast line, N43°03'54"W 60.67 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, continuing along said northeast line, N58°04'20"W 67.79 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, continuing along said northeast line, N47°12'54"W 76.08 feet to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, N33°30'20"W 76.96 feet to a 3/8 inch square boat spike; thence, N15°40'32"W 155.42 feet along the east line of Cabinet View per Plat No. 49, to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, N83°03'32"E 149.52 feet along the south line of Highwood Park per Plat No. 49, to a 5/8 inch dia. rebar capped M.D.L. 4232-S; thence, N06°44'47"W 300.59 feet along the east line of said Highwood Park, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N82°58'38"E 291.78 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S00°00'42"W 845.03 feet to the point of beginning.
