
"CORRECTION" CERTIFICATE OF SURVEY

"FAMILY TRANSFER" T. 36N., R.27 W., P.M.,MT. NE 1/4 NW 1/4 SE 1/4, SECTION 10 LINCOLN COUNTY, MONTANA



PURPOSE OF SURVEY

The purpose of this survey is to correct the Legal Desciption of Parcel "A" to read " ... in the NE_1^1 NW_2^1 SE_2^1 ..." Therefore this parcel is exempt from review as a subdivision pursuant to Section 76-3-104, M.C.A.

METHOD OF SURVEY

A total station and RTK GPS was used with closed traverse procedures to tie previously set controlling monuments.

BASIS OF BEARING

The basis of bearing for this survey is N00°24'53"E, as shown on COS No. 443. between the E 1/4 corner of Section 10 and the SE corner of Section 10, a 5/8 inch rebar marked 2561-s and a BLM brass cap monument.

LEGAL DESCRIPTION PARCEL "A"

An irregular tract of land, lying northwest of Eureka, Montana, Lincoln County, and in the NE1/4 NW1/4 SE1/4, Section 10, T.36N., R.27W., P.M., MT., containing ±2.000 acres, and more particularly described as follows:

Commencing at the east 1/4 corner of said Section 10, a 5/8 inch rebar marked 2516-S; Thence, N88*41'26"W, 1332.86 feet computed location being the CE 1/16 corner of said Section 10; thence, S00*32'23"W, 253.65 feet along the north-south centerline of the SE 1/4 of said Section 10, to a computed set 5/8 inch rebar marked Hughes 7322-LS being the True Point of Beginning:

Thence S00°32'23"W, 404.33 feet to a found 5/8 inch rebar, marked Hughes 7322LS, being the CNSE 1/64 corner of said Section 10 and the north west corner of the Remainder of Cos No. 3036;

Thence N88°35'25"W, 214.55 feet to a set 5/8 inch rebar, marked Hughes 7322LS; Thence N00°32'23"E, 407.88 feet to a set 5/8 inch rebar, marked Hughes 7322LS; Thence S87°38'41"E, 214.63 feet to a set 5/8 inch rebar, marked Hughes 7322LS, and being the True Point of Beginning, containing ±2.000 acres. Subject to and together with all appurtenant easements of record.
